

1 FIRST AMENDMENT TO AGREEMENT NO. 35903

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 35903 is made and
4 entered, in duplicate, as of June 9, 2022, for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on April 13,
6 2021, by and between INTELINET INCORPORATED, a California corporation
7 ("Consultant"), with a place of business at 9106 Pulsar Court, Unit H, Corona, California
8 92883, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 35903 (the "Agreement") whereby Consultant agreed to provide as-needed Citywide data,
11 telephone, and fiber optic structured cabling; and

12 WHEREAS, the Parties desire to add \$500,000 to the Agreement for a total
13 not to exceed amount of \$1,300,000;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
15 conditions herein contained, the Parties agree as follows:

16 1. Section 1.A. of the Agreement is hereby amended to read as follows:

17 "A. Consultant shall furnish specialized services more particularly
18 described in Exhibit "A", attached to this Agreement and incorporated by this
19 reference, in accordance with the standards of the profession, and City shall pay for
20 these services in the manner described below, in an annual amount not to exceed
21 One Million Three Hundred Thousand Dollars (\$1,300,000), at the rates or charges
22 shown in Exhibit "B"."

23 2. Except as expressly modified herein, all of the terms and conditions
24 contained in Agreement No. 35903 are ratified and confirmed and shall remain in full force
25 and effect.




