

RESOLUTION NO. RES-11-0064

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO PURCHASE ONE FIRE PUMPER TRUCK THROUGH THE AGREEMENT BETWEEN THE CITY OF PORTLAND, MAINE AND SEAGRAVE FIRE APPARATUS, LLC FOR AN AMOUNT NOT TO EXCEED \$592,010

WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City desires to purchase one (1) Fire Pumper Truck; and

WHEREAS, Seagrave Fire Apparatus, LLC has an Agreement with the City of Portland, Maine for the purchase of a Fire Pumper Truck ("Portland Agreement"); and

WHEREAS, the City's participation in the Portland Agreement will facilitate acquisition of one (1) Fire Pumper Truck as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to utilize a formal bid process rather than participate in the Portland Agreement considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

1. The above recitals are true and correct and are incorporated herein by this reference.

2. The City Manager of the City is hereby authorized to enter an agreement with Seagrave Fire Apparatus, LLC to purchase (1) Fire Pumper Truck, of substantially the same type and kind purchased by the City of Portland, Maine except as

1 modified by mutual agreement of the City and Seagrave Fire Apparatus, LLC, and the  
2 purchase by the City shall be on the same terms and conditions afforded to the City of  
3 Portland, Maine in a total amount not to exceed \$592,010, including tax, for a period  
4 extending until the warranty expires. This resolution shall take effect immediately upon  
5 its adoption by the City Council, and the City Clerk shall certify the vote adopting this  
6 resolution.
