RESOLUTION NO. RES-22-0041

A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH APPROVING APPLICATIONS FOR
PER CAPITA GRANT FUNDS FOR CAPITAL
IMPROVEMENTS AT DEFOREST PARK

WHEREAS, the State Department of Parks and Recreation has been
delegated the responsibility by the Legislature of the State of California for the
administration of the Per Capita Grant Program, setting up necessary procedures
governing application(s); and

WHEREAS, said procedures established by the State Department of Parks
and Recreation require the City of Long Beach ("City" or "Grantee") to certify by resolution
the approval of project application(s) before submission of said applications to the State;
and

WHEREAS, the Grantee will enter into a contract(s) with the State of
California to complete project(s);

NOW, THEREFORE, the City Council of the City of Long Beach resolves as
follows:

Section 1. This resolution shall take effect immediately upon its adoption
by the City Council, and the City Clerk shall certify the vote adopting this resolution.

Section 2. Approves the filing of project application(s) for Per Capita
program grant project of \$177,952 for capital improvements at DeForest Park in the City of
Long Beach; and

Section 3. Certifies that said Grantee has or will have available, prior to
commencement of project work utilizing Per Capita funding, sufficient funds to complete
the project(s); and

Section 4. Certifies that the Grantee has or will have sufficient funds to

1 operate and maintain the project(s), and

2 Section 5. Certifies that all projects proposed will be consistent with the
3 park and recreation element of the City of Long Beach’s general or recreation plan (PRC
4 §80063(a)), and

5 Section 6. Certifies that these funds will be used to supplement, not
6 supplant, local revenues in existence as of June 5, 2018 (PRC §80062(d)), and

7 Section 7. Certifies that it will comply with the provisions of §1771.5 of the
8 State Labor Code, and

9 Section 8. (PRC §80001(b)(8)(A-G)) To the extent practicable, as
10 identified in the “Presidential Memorandum--Promoting Diversity and Inclusion in Our
11 National Parks, National Forests, and Other Public Lands and Waters,” dated January 12,
12 2017, the City of Long Beach will consider a range of actions that include, but are not
13 limited to, the following:

14 A. Conducting active outreach to diverse populations, particularly
15 minority, low-income, and disabled populations and tribal communities, to
16 increase awareness within those communities and the public generally about
17 specific programs and opportunities.

18 B. Mentoring new environmental, outdoor recreation, and
19 conservation leaders to increase diverse representation across these areas.

20 C. Creating new partnerships with state, local, tribal, private, and
21 nonprofit organizations to expand access for diverse populations.

22 D. Identifying and implementing improvements to existing
23 programs to increase visitation and access by diverse populations,
24 particularly minority, low-income, and disabled populations and tribal
25 communities.

26 E. Expanding the use of multilingual and culturally appropriate
27 materials in public communications and educational strategies, including
28 through social media strategies, as appropriate, that target diverse

1 populations.

2 F. Developing or expanding coordinated efforts to promote youth
3 engagement and empowerment, including fostering new partnerships with
4 diversity-serving and youth-serving organizations, urban areas, and
5 programs.

6 G. Identifying possible staff liaisons to diverse populations.

7 Section 9. Agrees that to the extent practicable, the project(s) will provide
8 workforce education and training, contractor and job opportunities for disadvantaged
9 communities (PRC §80001(b)(5)).

10 Section 10. Certifies that the Grantee shall not reduce the amount of
11 funding otherwise available to be spent on parks or other projects eligible for funds under
12 this division in its jurisdiction. A one-time allocation of other funding that has been
13 expended for parks or other projects, but which is not available on an ongoing basis, shall
14 not be considered when calculating a recipient's annual expenditures. (PRC §80062(d)).

15 Section 11. Certifies that the Grantee has reviewed, understands, and
16 agrees to the General Provisions contained in the contract shown in the Procedural Guide;
17 and

18 Section 12. Delegates the authority to the City Manager, or designee to
19 conduct all negotiations, sign and submit all documents, including, but not limited to
20 applications, agreements, amendments, and payment requests, which may be necessary
21 for the completion of the grant scope(s); and

22 Section 13. Agrees to comply with all applicable federal, state and local
23 laws, ordinances, rules, regulations and guidelines.
