3 THIS FIRST AMENDMENT TO CONTRACT NO. 31471 is made and  
4 entered, in duplicate, as of October 18, 2010 for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on  
6 December 15, 2009, by and between ALL AMERICAN ASPHALT, a California  
7 corporation ("Contractor"), whose address is 400 E. Sixth Street, Corona, California  
8 92879, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, pursuant to a "Notice Inviting Bids for the Annual Contract for  
10 Street Improvements in the City of Long Beach, California," bids were received, publicly  
11 opened on November 18, 2009 and declared on the date specified in said Notice; and

12 WHEREAS, the parties entered Contract No. 31471 for the work described  
13 in the bid documents; and

14 WHEREAS, the parties desire to extend the term;

15 NOW, THEREFORE, in consideration of the mutual terms and conditions in  
16 the Contract and in this First Amendment, the parties agree as follows:

17 1. Section 4 of Contract No. 31471 is hereby amended to read as  
18 follows:

19 "4. TIME FOR CONTRACT. The term of this Contract shall begin on  
20 December 16, 2009 and shall end on March 1, 2012 or on City's payment of the not-to  
21 exceed dollar amount hereunder to Contractor as specified in Section 2, whichever  
22 occurs first."

23 2. Except as expressly amended in this First Amendment, all terms and  
24 conditions in Contract No. 31471 are ratified and confirmed and shall remain in full force  
25 and effect.

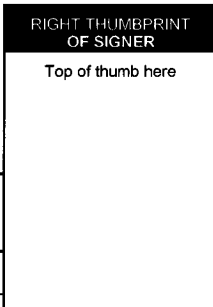
