SUBJECT: Resolution to Furnish and Deliver Commercial Trash Containers Through the City of Ontario's Purchase Order Number 12593 With Consolidated Fabricators Corporation (Citywide)

## DISCUSSION

City Council approval is requested to enter into an annual contract to furnish and deliver commercial trash containers (up to 8 cubic yards) to support the Department of Public Work's new front-loading refuse trucks, and to continue the City's ongoing commercial and residential refuse maintenance program. This request would allow for the purchase of approximately 550 containers. Replacing the City's current 2-cubic yard trash containers with larger containers, as needed, will minimize overflow trash, reduce collections and thus reduce heavy-duty vehicle traffic in alleys.

The City Charter provides for an alternative procurement method by permitting the City to purchase or otherwise obtain services, supplies, materials, equipment and labor with other governmental agencies by purchasing under their contracts on a voluntary and selective basis, once authorized by a Resolution of the City Council. The Department of Public Works investigated various procurement options and learned that the City of Ontario had recently completed a competitive bid process for the purchase of commercial trash containers and has a contract in place with Consolidated Fabricators Corporation. Purchasing the commercial trash containers under the terms and conditions of the City of Ontario's Purchase Order Number 12593 will expedite the acquisition of the trash containers to coincide with the delivery schedule of the new refuse vehicles.

This matter was reviewed by Senior Deputy City Attorney Donna F. Gwin on October 5, 2004 and by Budget Management Officer David Wodynski on October 20, 2004.

## TIMING CONSIDERATIONS

City Council action to adopt the attached Resolution and award the contract concurrently is requested on November 9, 2004 to ensure trash containers are delivered to coincide with the delivery of the new refuse trucks.

Adopt the attached Resolution authorizing the City Manager to execute a contract with Consolidated Fabricators Corporation, to purchase commercial trash containers pursuant to the City of Ontario's Purchase Order 12593, under the terms and conditions afforded to the City of Ontario in an estimated amount not to exceed \$300,000.
