AN ORDINANCE OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH AMENDING THE LONG BEACH
MUNICIPAL CODE BY ADDING SUBSECTION 2.03.060.C
RELATING TO COMMITTEES

The City Council of the City of Long Beach ordains as follows:

Section 1. Subsection 2.03.060.C is added to the Long Beach Municipal
Code to read as follows:

C. An agenda shall be prepared containing the specific items of
business to be transacted, along with a brief general description of each
item to be heard at a committee meeting. Items of business shall be placed
on the agenda at the direction of the chairman, vice chairman, or member
of such committee.

Section 2. The City Clerk shall certify to the passage of this ordinance by
the City Council and cause it to be posted in three (3) conspicuous places in the City of
Long Beach, and it shall take effect on the thirty-first (31st) day after it is approved by the
Mayor.
