

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF LONG BEACH ESTABLISHING SERVICE FEES  
RELATING TO FALSE ALARMS

WHEREAS, Section 5.12.120, Subsection A, of the Long Beach Municipal Code requires the City to charge a service fee, to be established by resolution, for certain false alarms to which the Long Beach Police Department has responded;

WHEREAS, the City Council of the City of Long Beach on November 22, 1983 adopted Resolution No. C-23637 establishing the required service fees and on September 18, 1989, December 20, 1994 and August 12, 1997 amended such fees;

WHEREAS, prior to adoption of this resolution revising such fees, public notice and hearing have been given in accordance with Section 66018 of the California Government Code;

WHEREAS, the City Council desires to amend those fees as previously established;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. In accordance with Subsection A of Section 5.12.120 of the Long Beach Municipal Code, the following service fees shall be charged to the licensees of burglar alarm systems in relation to false alarms:

Third false alarm in a twelve month period:	\$50.00
Fourth false alarm in a twelve month period:	\$150.00
Fifth false alarm in a twelve month period:	\$250.00
Any subsequent false alarm in a twelve month period:	\$350.00

Sec. 2. Resolution No. C-26223 is hereby repealed.
