3 THIS FIRST AMENDMENT TO AGREEMENT NO. 35012 is made and
4 entered, in duplicate, as of June 30, 2021, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on June
6 19, 2018, by and between ALLIANT INSURANCE SERVICES, INC., a Delaware
7 corporation ("Consultant"), with a place of business at 1301 Dove Street, Suite 200,
8 Newport Beach, California 92660, and the CITY OF LONG BEACH, a municipal
9 corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with healthcare, employee benefits consulting, and actuarial
12 services; and

13 WHEREAS, City and Consultant entered into Agreement No. 35012 whereby
14 Consultant agreed to provide these services; and

15 WHEREAS, City and Consultant desire to extend the term of Agreement No.
16 35012 for an additional one year as authorized by City Council on June 19, 2018;

17 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
18 conditions in the Agreement and this Amendment, the parties agree as follows:

19 1. Section 2 of Agreement No. 35012 is hereby amended to read as
20 follows:

21 "2. TERM. The term of this Agreement shall commence at midnight on
22 July 1, 2018, and shall terminate at 11:59 p.m. on June 30, 2022, unless sooner terminated
23 as provided in this Agreement, or unless the services or the Project is completed sooner."

24 2. Except as expressly modified herein, all of the terms and conditions
25 contained in Agreement No. 35012 are ratified and confirmed and shall remain in full force
26 and effect.

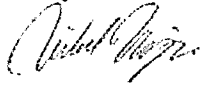

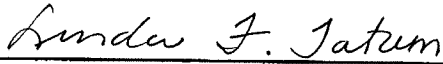

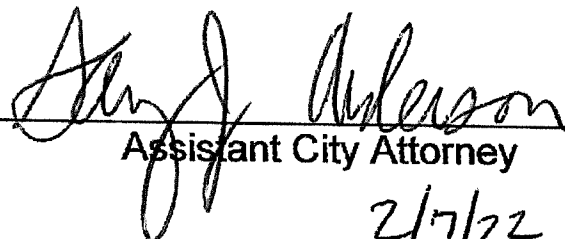
