A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO PURCHASE TRUCKS, CABS AND CHASSIS THROUGH THE CONTRACT BETWEEN THE GENERAL SERVICES ADMINISTRATION (GSA) AND DOWNTOWN FORD SALES, HOBLIT MOTORS, H.W. HUNTER, INC., VICTOR BUICK-GMC TRUCK INC., HOBLIT-HAYNES DODGE CHRYSLER, JEEP, ELK GROVE AUTO GROUP, INC., AND COALINGA MOTORS INC.

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City of Long Beach desires to purchase approximately thirtyfour (34) trucks, cabs and chassis; and

WHEREAS, the State of California, Department of General Services ("GSA"), has contracts for the purchase of these trucks, cabs and chassis with Downtown Ford Sales, Hoblit Motors, H.W. Hunter, Inc., Victor Buick-Gmc Truck Inc., Hoblit-Haynes Dodge, Chrysler, Jeep, Elk Grove Auto Group, Inc., and Coalinga Motors Inc. ("GSA Contracts No. 1-05-23-20"); and

WHEREAS, City's participation in the GSA Contracts No. 1-05-23-20 will facilitate acquisition of these trucks, cabs, and chassis as well as provide considerable costs benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the GSA Contracts No. 1-05-23-20 considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated hereby by this reference.

Sec. 2. The City Manager of the City of Long Beach is hereby authorized to enter agreements with Downtown Ford, Hoblit Motors, H.W. Hunter, Inc., Victor Buick-Gmc Truck Inc., Hoblit-Haynes Dodge, Chrysler, Jeep, Elk Grove Auto Group, Inc., and Coalinga Motors Inc. to purchase thirty-four (34) trucks, cabs, and chassis of substantially the same type and kind offered by the GSA Contracts No. 1-05-23-20 pursuant to the terms and conditions of GSA Contracts No.1-05-23-20 except as modified by mutual agreement of the City of Long Beach and the various vendors of these items and the purchase by the City of Long Beach shall be on the same terms and conditions afforded to the GSA in an amount not to exceed \$575,174.00 including tax and extras, for a period extending until the warranty on the trucks expire.

Sec. 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
