1 SECOND AMENDMENT TO AGREEMENT NO. 34167

3 THIS SECOND AMENDMENT TO AGREEMENT NO. 34167 is made and
4 entered, in duplicate, as of August 25, 2017, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 June 20, 2017, by and between AMERICAN CORRECTIONAL SOLUTIONS, INC., a
7 California corporation ("Contractor"), with a place of business at 741 E. Ball Road, Ste.
8 #205, Anaheim, CA 92805, and the CITY OF LONG BEACH, a municipal corporation
9 ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with Jail Inmate Medical Services; and

12 WHEREAS, the parties entered Agreement No. 34167 ("Contract") whereby
13 Contractor agreed to provide these services; and

14 WHEREAS, the parties desire to extend the term of the Contract, update
15 the cost schedule, and include the City's Holiday schedule to the Contract;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions herein contained, the parties agree as follows:

18 1. Section 2 of Agreement No. 34167 is hereby amended to read as
19 follows:

20 "2. TERM. The term of this Agreement shall commence at
21 midnight on September 1, 2017, and shall terminate at 11:59 p.m. on September
22 1, 2018, unless sooner terminated as provided in this Agreement, or unless the
23 services or the Project is completed sooner. The parties have the option to extend
24 the term for one (1) additional one-year period."

25 2. The Rates or Charges in Exhibit "A" to the Agreement are hereby
26 amended to include revised hourly rates, overtime, and holiday pay in accordance with
27 the Holiday Schedule, attached hereto and incorporated by this reference as Exhibit "A".

28 3. Except as expressly modified herein, all the terms and conditions

1 contained in Agreement No. 34167 are ratified and confirmed and shall remain in full
2 force and effect.

4 executed with all formalities required by law as of the date first stated above.
