

DECLARATION

I am the widow of George Wallace Carver, who died on or about the 27 day of December, 2004; that the decedent at the time of his death was a retired firefighter with the Long Beach Fire Department; that the declarant and George Wallace were married on September 16, 1945, in the City of Las Vegas, State of Nevada, and that said marriage continued until the death of Mr. Carver.

That the declarant makes this declaration for the purpose of obtaining a pension under the provisions of Subsection (4) of Section 187 of the Charter of the City of Long Beach, prior to its repeal.

I declare under penalty of perjury under the laws of the State of Colorado that the foregoing statement is true and correct.

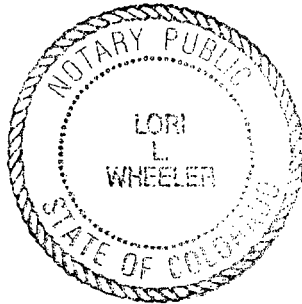

MINUTE ORDER

FOR THE ADOPTION OF A WIDOW'S PENSION

BY

Councilmember _____ moved, second by Councilmember _____, that the communication of the City Attorney and the accompanying declaration be received and filed, and it appearing from the application for a widow's pension that, George Wallace Carver, who died on or about December 27, 2004, was a retired Firefighter in the Long Beach Fire Department, having retired from active duty on September 28, 1968; that Verneil Carver is his widow and is entitled to be granted and to be paid during her lifetime, or until she remarries, an annual pension equal to fifty percent (50%) of the salary attached to the rank of Firefighter, to become effective December 28, 2004, and that such payments shall be made from such funds as the City may be required to provide for that purpose.
