1 FIRST AMENDMENT TO CONTRACT NO. 34480

3 THIS FIRST AMENDMENT TO CONTRACT NO. 34480 is made and
4 entered, in duplicate, as of April 13, 2018 for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting held on July 5,
6 2016, by and between CORRAL CONSTRUCTION & DEVELOPMENT INC., a California
7 corporation ("Contractor"), whose address is 5211 East Washington Boulevard, #2-122,
8 Commerce, California 90040 and the CITY OF LONG BEACH, a municipal corporation
9 ("City").

10 WHEREAS, City and Contractor (the "Parties") entered into Contract No.
11 34480 whereby Contractor agreed to provide the work described in Bid Number ITB DV16-
12 161; and

13 WHEREAS, the Parties desire to extend the term one (1) additional one-year
14 period;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants and
16 conditions herein contained, the Parties agree as follows:

17 1. Section 4 of Agreement No. 34480 is hereby amended to read as
18 follows:

19 "4. TIME FOR CONTRACT. Contractor shall commence work on a date
20 to be specified in a written "Notice to Proceed" from City and shall complete all work by
21 April 14, 2019, subject to strikes, lockouts and events beyond the control of Contractor.
22 Time is of the essence hereunder. City will suffer damage if the work is not completed
23 within the time stated, but those damages would be difficult or impractical to determine.
24 So, Contractor shall pay to City, as liquidated damages, the amount stated in the Contract
25 Documents."

26 2. Except as expressly modified herein, all of the terms and conditions
27 contained in Contract No. 34480 are ratified and confirmed and shall remain in full force
28 and effect.
