This Amendment to Contract No. 34311 is made and entered as of June 8, 2018, by and between the CITY OF LONG BEACH, a municipal corporation, and United Rotary Brush Corporation.

Contract No. 34311 is amended by mutual agreement of the parties and as indicated below by a check or other mark preceding the appropriate amendment:

- 1. The term is extended to 07/26/19

- 8. The locations identified on Exhibit "B", which is attached hereto and incorporated herein by this reference, are hereby added to the Contract.



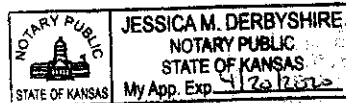
