## THIRD AMENDMENT TO AGREEMENT NO. 34974

## 

THIS THIRD AMENDMENT TO AGREEMENT NO. 34974 is made and entered, in duplicate, as of June 9, 2021 for reference purposes only, pursuant to Resolution No. RES-18-0092 adopted by the City Council of the City of Long Beach at its meeting on June 19, 2018, by and between COMPUTER AID, INC., a Pennsylvania corporation ("Contractor"), whose address is 1390 Ridgeview Drive, Allentown, Pennsylvania 18014, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 34974 (the "Agreement"), as authorized by Resolution No. RES-18-0092, whereby Contractor agreed to sell, furnish, install and configure to the City information technology systems; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to July 31, 2020; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to July 31, 2021 and add the annual authorized amount of \$1,250,000 for a total not to exceed amount of \$6,418,000; and

WHEREAS, the Parties desire to extend the term to March 3, 2022 and add the annual authorized amount of \$1,250,000 for a total not to exceed amount of \$7,668,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.D. of Agreement No. 34974 is hereby amended to read as follows:
- "D. The term of this Agreement shall commence at midnight on June 19, 2018, and shall terminate at 11:59 p.m. on March 3, 2022."
- 2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34974 are ratified and confirmed and shall remain in full force
