3 THIS THIRD AMENDMENT TO AGREEMENT NO. 34974 is made and
4 entered, in duplicate, as of June 9, 2021 for reference purposes only, pursuant to
5 Resolution No. RES-18-0092 adopted by the City Council of the City of Long Beach at its
6 meeting on June 19, 2018, by and between COMPUTER AID, INC., a Pennsylvania
7 corporation ("Contractor"), whose address is 1390 Ridgeview Drive, Allentown,
8 Pennsylvania 18014, and the CITY OF LONG BEACH ("City"), a municipal corporation.

9 WHEREAS, City and Contractor (the "Parties") entered into Agreement No.
10 34974 (the "Agreement"), as authorized by Resolution No. RES-18-0092, whereby
11 Contractor agreed to sell, furnish, install and configure to the City information technology
12 systems; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to
14 extend the term to July 31, 2020; and

15 WHEREAS, the Parties entered into a Second Amendment to the Agreement
16 to extend the term to July 31, 2021 and add the annual authorized amount of \$1,250,000
17 for a total not to exceed amount of \$6,418,000; and

18 WHEREAS, the Parties desire to extend the term to March 3, 2022 and add
19 the annual authorized amount of \$1,250,000 for a total not to exceed amount of
20 \$7,668,000;

21 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
22 conditions herein contained, the Parties agree as follows:

23 1. Section 1.D. of Agreement No. 34974 is hereby amended to read as
24 follows:

25 "D. The term of this Agreement shall commence at midnight on June 19,
26 2018, and shall terminate at 11:59 p.m. on March 3, 2022."

27 2. Except as expressly modified herein, all of the terms and conditions
28 contained in Agreement No. 34974 are ratified and confirmed and shall remain in full force
