Recommended ABC Conditions for  
Walmart Store #3477  
7250 Carson Blvd

**Hours of sales:**

- The sales and service of alcoholic beverages shall be permitted only from the hours of 6:00am until 2:00am each day of the week.
- The sales and service of alcoholic beverages shall be permitted only from the hours of 6:00am until 2:00am Sunday through Thursday and 6:00am until 2:00am Friday and Saturday.

**Amusement Machines/Pay Phones**

- There shall be no amusement machines or video game devices on the premises at any time.
- No pay phone shall be maintained on the interior or exterior of the premises.

**Security:**

- Permittee(s) shall provide a licensed uniformed security guard(s) at each operational exit between the hours of 6:00am to 2:00am.
- Between the hours of 6:00am until 2:00am, the permittee(s) shall provide a licensed uniformed security guard(s) in the parking lot and shall maintain order therein and prevent any alcohol related activity that may occur.

**Litter/Loitering:**

- The Permittee(s) shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control.
- Permittee(s) shall prevent the loitering of persons around the premises.
- The possession of alcoholic beverages in open containers, and the consumption of alcoholic beverages is prohibited on or around the premises.

**Parking Lot:**

- The parking lot of the premise shall be equipped with lighting of sufficient power to illuminate and make easily discernible the appearance and conduct of all persons on or about the parking lot.
- The Permittee(s) shall post and maintain a professional quality sign facing the premises parking lot(s) that reads as follows:

NO LOITERING, NO LITTERING  
NO DRINKING OF ALCOHOLIC BEVERAGES  
VIOLATORS ARE SUBJECT TO ARREST

The sign shall be at least two (2) feet square with two (2) inch block lettering. The sign shall be in English and Spanish.

**Quantities/Size:**

- No beer or malt beverage products shall be sold, regardless of container size, in quantities of less than three (3) per sale.
- Wine shall not be sold in containers smaller than 750 ml. And wine coolers, beer coolers, or pre-mixed distilled spirit cocktails must be sold in manufacturer pre-packaged multi-unit quantities.
- Distilled Spirits shall not be sold in containers smaller than 750ml.

**Consumption:**

- No alcoholic beverages shall be consumed on any property adjacent to the licensed premises under the control of the licensee(s).

**Sales:**

- Sale and delivery of distilled spirits to customers shall be made from behind a counter where a clerk will obtain the product; no self-service of distilled spirits will be permitted.

**Advertisement:**

- There shall be no exterior advertising or sign of any kind or type, including advertising directed to the exterior from within, promoting or indicating the availability of alcoholic beverages. Interior displays of alcoholic beverages or signs which are clearly visible to the exterior shall constitute a violation of this condition.

**Premise-to-Premise Transfers:**

- This license shall not be transferred to a different premise within the City of Long Beach.


