3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO PURCHASE ONE (1) NEW AND ONE (1)
6 PREVIOUSLY OWNED AERIAL LADDER TRUCK
7 THROUGH THE CONTRACT BETWEEN THE VILLAGE OF
8 RIDGEFIELD PARK AND SEAGRAVE FIRE APPARATUS,
9 LLC

11 WHEREAS, the Charter of the City of Long Beach, Section 1802, permits
12 the City to purchase services, supplies, materials, equipment and labor with other
13 government agencies by purchasing under their contracts on a voluntary and selective
14 basis when authorized by resolution; and

15 WHEREAS, the Village of Ridgefield Park has a contract for the purchase
16 of aerial ladder trucks through its Contract dated as of December 17, 2003 ("Ridgefield
17 Park Contract"); and

18 WHEREAS, the City's participation in the Ridgefield Park Contract will
19 facilitate acquisition of these trucks as well as provide considerable costs benefits to the
20 City; and

21 WHEREAS, if the City had to go to formal bid rather than participate in the
22 Ridgefield Park Contract considerably more funds would be required; and

23 WHEREAS, Resolution C-28461 was adopted by the City Council of the
24 City of Long Beach at its meeting held on October 5, 2004 authorizing the City Manager
25 to enter into an agreement to purchase one (1) aerial ladder truck with the option to
26 amend the agreement for the purchase of additional vehicles while the original vehicle is
27 still under warranty; and

28 WHEREAS, the City entered into Agreement No. 29136 with Seagrave Fire

1 Apparatus, LLC to purchase the aerial ladder truck; and

2 WHEREAS, the City of Long Beach now desires to amend Agreement No.
3 29136 for the purchase of one (1) new and one (1) previously owned aerial ladder truck;

4 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
5 follows:

6 Section 1. The above recitals are true and correct and are incorporated
7 herein by this reference.

8 Section 2. The City Manager of the City of Long Beach is hereby
9 authorized to amend Agreement No. 29136 with Seagrave Fire Apparatus, LLC. to
10 purchase one (1) new and one (1) previously owned aerial ladder truck of substantially
11 the same type and kind purchased by the City of Ridgefield Park pursuant to the
12 Ridgefield Park Contract except as modified by mutual agreement of the City of Long
13 Beach and Seagrave Fire Apparatus LLC, and the purchase by the City of Long Beach
14 shall be on the same terms and conditions afforded to the City of Ridgefield Park in an
15 amount not to exceed \$1,304,108.00 including tax, plus a 10% contingency for additional
16 equipment if necessary.

17 Section 3. This resolution shall take effect immediately upon its adoption
18 by the City Council, and the City Clerk shall certify the vote adopting this resolution.

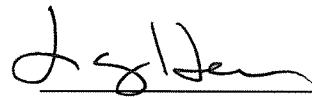
