3 THIS FIRST AMENDMENT TO PERMIT NO. P-00189 is made and entered,  
4 in duplicate, as of June 26, 2021, for reference purposes only, pursuant to authorization by  
5 the PARKS AND RECREATION COMMISSION of the City of Long Beach at its meeting  
6 on June, 21, 2018, by and between PEDAL MOVEMENT LLC, a California limited liability  
7 company ("Permittee"), whose address is 223 E. 1st Street, Long Beach, California, 90802,  
8 and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the Parties executed Permit No. P-00189 wherein Permittee  
10 agreed to install and operate CycleLink Mobility Hub at 14th Street Park and Willow Springs  
11 Park; and

12 WHEREAS, the parties desire to amend this Permit by extending the term;

13 NOW, THEREFORE, in consideration of the mutual terms and conditions in  
14 Permit No. P-00189, the Parties agree as follows:

15 1. Section 3.A. of the Agreement is hereby amended to read as follows.

16 "3. DURATION OF PERMIT

17 A. Permission to enter shall begin on July 1, 2018, and continue  
18 through June 30, 2024. The term may be extended for two (2) additional three-  
19 year periods at the discretion of the Department of Parks, Recreation & Marine  
20 Director ("Director")."

21 2. Except as expressly modified herein, all of the terms, covenants, and  
22 conditions contained of Permit No. P-00189 are ratified and confirmed and shall remain in  
23 full force and effect.




