3 AN ORDINANCE OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH AMENDING THE LONG BEACH  
5 MUNICIPAL CODE BY AMENDING SECTION 1.21.010  
6 ORDERING THE CITY CLERK TO CANVASS THE  
7 MUNICIPAL ELECTIONS HELD IN THE CITY OF LONG  
8 BEACH

10 The City Council of the City of Long Beach ordains as follows:

11  
12 Section 1. Section 1.21.010 of the Long Beach Municipal Code is  
13 amended to read as follows:

14 1.21.010 Canvass of returns.

15 Notwithstanding the provisions of California Elections Code 10262  
16 and 10263, the canvass of each municipal election held in the City of  
17 Long Beach is ordered to be made by the City Clerk within twenty-one  
18 days after the date of the election. Upon completion of the canvass, the  
19 City Clerk shall certify the results to the City Council who shall thereupon  
20 meet and shall adopt a resolution reciting the fact of the election and the  
21 statement of the result as provided in Section 10264 of the California  
22 Elections Code.

23  
24 Sec. 2. The City Clerk shall certify to the passage of this ordinance by the  
25 City Council and cause it to be posted in three conspicuous places in the City of Long  
26 Beach, and it shall take effect on the thirty-first day after it is approved by the Mayor.




