WHEREAS, the parties desire to extend the term of the Contract;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Contract and this Second Amendment, the parties agree as follows:

- 1. Section 2 of Contract No. 29929 is hereby amended in its entirety to read as follows:
- "2. The initial term of this Contract shall begin on October 1, 2006 and end on September 30, 2007. The first extended term of this Contract shall begin on October 1, 2007 and end on September 30, 2008. This Contract only governs services provided to City's residents and persons seeking housing in the City. This Contract may be renewed on the same terms and conditions for one (1) consecutive period of one (1) year on mutual agreement between the parties."
- 2. Except as expressly amended in this Second Amendment, all terms and conditions in Contract No. 29929 are ratified and confirmed and shall remain in full force and effect.
