1 FIRST AMENDMENT TO AGREEMENT NO. 29238

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 29238 ("Amendment") is  
4 made and entered, in duplicate, as of April 30, 2006, for reference purposes only, pursuant  
5 to a minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 June 21, 2005, by and between COMMUNITY HOSPITAL OF LONG BEACH, a public  
7 benefit corporation ("Contractor"), and the CITY OF LONG BEACH ("City").

8 WHEREAS, the parties entered Agreement No. 29238 whereby Contractor  
9 agreed to provide emergency services with respect to persons booked by the City's Police  
10 Department and victims of certain crimes; and

11 WHEREAS, the parties desire to extend the term of said Agreement;

12 NOW, THEREFORE, in consideration of the mutual terms and conditions in  
13 Agreement No. 29238 and herein, the parties agree as follows:

14 1. Section 2 of Agreement No. 29238 is hereby amended in its entirety to  
15 read as follows:

16 "2. The term of this Agreement shall commence at midnight on  
17 May 1, 2006, and shall terminate at midnight on April 30, 2007. City shall have the  
18 option to extend the term of this Agreement for one (1) additional year, upon  
19 authorization by City's City Council."

20 2. Exhibit "A" to the Agreement is hereby amended so that the fees shown  
21 on Exhibit "A" to this Amendment supercede the same described fees in Exhibit "A" to the  
22 Agreement. All fees listed in Exhibit "A" to the Agreement that are not listed in Exhibit "A"  
23 to this Amendment shall remain in full force and effect without amendment.

24 3. Except as expressly amended herein, all terms and conditions in  
25 Agreement No. 29238 are ratified and confirmed and shall remain in full force and effect.
