FIRST AMENDMENT TO AGREEMENT NO. 34856  
**34856**

THIS FIRST AMENDMENT TO AGREEMENT NO. 34856 is made and entered, as of August 8, 2022, for reference purposes only, pursuant to Resolution No. RES-17-0124 adopted by the City Council of the City of Long Beach at its meeting on October 17, 2017, by and between REHRIG PACIFIC COMPANY, a Delaware corporation ("Contractor"), whose address is 4010 E. 26<sup>th</sup> Street, Los Angeles, California 90023, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 34856 (the "Agreement") for the purchase and delivery of refuse and recycling containers on the same terms and conditions afforded to Miami-Dade County, Florida, in an annual amount not to exceed Nine Hundred Thousand Dollars (\$900,000), for a period of five (5) years, with the option to renew for one (1) additional five-year period, at the discretion of the City Manager; and

WHEREAS, the Parties desire to utilize their option to extend the term for an additional five (5) years;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.D. of the Agreement is hereby amended to read as follows:

"D. The term of this Agreement shall commence at midnight on October 17, 2017, and shall terminate at 11:59 p.m. on October 16, 2027. The Parties have no further options to extend the term."

2. The Rates in Exhibit "B" to the Agreement are hereby amended in accordance with Exhibit "B-1" attached hereto and incorporated by this reference.

3. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34856 are ratified and confirmed and shall remain in full force and effect.
