

1 FOURTH AMENDMENT TO AGREEMENT NO. 32391

3 THIS FOURTH AMENDMENT TO AGREEMENT NO. 32391 is made and
4 entered, in duplicate, as of October 4, 2017 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 October 3, 2017, by and between FIDELITY NATIONAL INFORMATION SERVICES, INC.
7 formerly known as LINK2GOV CORP., a Tennessee corporation ("Consultant"), with a
8 place of business at 113 Seaboard Lane, Suite A-250, Franklin, Tennessee 37067, and
9 the CITY OF LONG BEACH, a municipal corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with credit card processing services; and

12 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
13 32391 (the "Agreement") whereby Consultant agreed to provide such services; and

14 WHEREAS, the Parties entered into a First Amendment to the Agreement to
15 extend the term and add \$160,000 for a total not to exceed amount of \$640,000; and

16 WHEREAS, the Parties entered into a Second Amendment to the Agreement
17 to extend the term; and

18 WHEREAS, the Parties entered into a Third Amendment to the Agreement
19 to extend the term and add \$276,000 for a total not to exceed amount of \$916,000; and

20 WHEREAS, the Parties desire to extend the term and increase the
21 Agreement amount by \$163,000 annually for a total not to exceed amount of \$1,242,000;

22 NOW, THEREFORE, in consideration of the mutual terms and conditions in
23 the Agreement and in this Amendment, the parties agree as follows:

24 1. Section 2 of Agreement No. 32391 is hereby amended to read as
25 follows:

26 "2. TERM. The term of this Agreement shall commence at midnight on
27 May 1, 2011, and shall terminate at 11:59 p.m. on October 30, 2019, unless sooner
28 terminated as provided in this Agreement, or unless the services or the Project is

1 completed sooner.”

2 2. An annual amount of One Hundred Sixty-Three Thousand Dollars
3 (\$163,000) is added to Agreement No. 32391 for the term ending October 30, 2019.

4 3. Except as expressly amended in this Fourth Amendment, all terms
5 and conditions in Agreement No. 32391 are ratified and confirmed and shall remain in full
6 force and effect.
