

1 FIRST AMENDMENT TO AGREEMENT NO. 33567

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33567 is made and
4 entered, in duplicate, as of August 30, 2016, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 September 9, 2014, by and between MLA GREEN, INC. DBA MIA LEHRER +
7 ASSOCIATES, a California corporation, with a place of business at 185 South Myers
8 Street, Los Angeles, California 90033 ("Consultant"), and the CITY OF LONG BEACH, a
9 municipal corporation ("City").

10 WHEREAS, the City requires specialized services requiring unique skills to
11 be performed in connection with architectural and engineering services related to the
12 planning and design of the Sorrento Alamitos Bay Shoreline Trail, Sidewalks, and Street
13 Improvements; and

14 WHEREAS, City and Consultant entered Agreement No. 33567 (the
15 "Agreement") whereby Consultant agreed to provide these services; and

16 WHEREAS, City and Consultant desire to increase the total not to exceed
17 Agreement amount to \$243,617 and extend the term to October 1, 2017;

18 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
19 conditions herein contained, the parties agree as follows:

20 1. Section 1.A. of the Agreement is hereby amended to read as follows:

21 "A. Consultant shall furnish specialized services more particularly
22 described in Exhibit "A", attached to the Agreement and incorporated by this
23 reference, in accordance with the standards of the profession, and City shall pay
24 for these services in the manner described below, not to exceed Two Hundred
25 Forty-Three Thousand Six Hundred Seventeen Dollars (\$243,617), at the rates or
26 charges shown in Exhibit "B".

27 2. Section 2 of the Agreement is hereby amended to read as follows:

1 "2. TERM. The term of this Agreement shall commence at midnight on
2 October 1, 2014, and shall terminate at 11:59 p.m. on October 1, 2017, unless sooner
3 terminated as provided in this Agreement, or unless the services or the Project is
4 completed sooner."

5 3. Except as expressly modified herein, all of the terms and conditions
6 contained in Agreement No. 33567 are ratified and confirmed and shall remain in full
7 force and effect.
