## FIRST AMENDMENT TO AGREEMENT NO. 33567

THIS FIRST AMENDMENT TO AGREEMENT NO. 33567 is made and entered, in duplicate, as of August 30, 2016, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on September 9, 2014, by and between MLA GREEN, INC. DBA MIA LEHRER + ASSOCIATES, a California corporation, with a place of business at 185 South Myers Street, Los Angeles, California 90033 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires specialized services requiring unique skills to be performed in connection with architectural and engineering services related to the planning and design of the Sorrento Alamitos Bay Shoreline Trail, Sidewalks, and Street Improvements; and

WHEREAS, City and Consultant entered Agreement No. 33567 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, City and Consultant desire to increase the total not to exceed Agreement amount to \$243,617 and extend the term to October 1, 2017;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to the Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Two Hundred Forty-Three Thousand Six Hundred Seventeen Dollars (\$243,617), at the rates or charges shown in Exhibit "B"."
  - 2. Section 2 of the Agreement is hereby amended to read as follows:
