#### **RECOMMENDATION:**

Receive the supporting documentation into the record, conclude the hearing, and grant an Entertainment Permit with conditions on the application of Hooched Up Ventures, LLC., dba Boomer's, 5456 E. Del Amo Boulevard, for entertainment with dancing. (District 5)

#### **DISCUSSION**

The Long Beach Municipal Code (LBMC) requires an application be filed and a hearing be held before the City Council whenever this type of activity is requested and before an entertainment permit (Permit) is granted or denied.

The LBMC also requires the City Council to approve the issuance of the Permit if they find that: the issuance of the Permit at the proposed location is consistent with federal, state and local laws, rules, and regulations; it will not constitute an undue burden on the neighborhood; the applicant(s) or responsible persons have not been convicted of any misdemeanor involving moral turpitude or felony offense within the past five years; and, neither the applicant(s) or any responsible persons have a history of committing significant violations of the City code and have not provided false or misleading information on their application.

The City Council has the authority to approve the following options: 1) grant the Permit, with or without conditions; or 2) deny the Permit on the application. Once the Permit is granted, pursuant to LBMC 5.72.120.5, the Permit will be subject to an administrative review by the Financial Management Department every two years. This review process will consist of a multi-department analysis to determine compliance and identify if issues exist. This provision does not affect the City's ability to modify, revoke or suspend a permit at any time.

City departments have conducted their investigations in accordance with the LBMC. Attached for your review are the departmental investigative reports, history, entertainment permit application, and floor plan. To review entertainment forms online, you may visit http://www.longbeach.gov/finance/services-and-permits/entertainment-permit.

The following summarizes departmental findings:

- The Police Department recommends the permit for entertainment with dancing be approved subject to the conditions.
- The Fire Department finds the building/location meets department requirements for the proposed use.
- The Health and Human Services Department finds the building/location meets department requirements for the proposed use with the condition that the establishment remain in compliance with the Long Beach Noise Ordinance (LBMC Chapter 8.80).
- The Development Services Department finds the building/location meets department requirements for the proposed use.

The Financial Management Department, Business Services Bureau, has reviewed all submitted department documents and correspondence and, after a thorough investigative process, recommends that the permit for entertainment with dancing be approved subject to conditions (attached).

In the event that any of the recommended conditions are in conflict with other permits or licenses, the permittee shall adhere to the strictest of the applicable conditions. This location has been licensed as a Bar, Tavern, Lounge since March 1995. The business changed ownership to Hooched Up Ventures, LLC., in November 2017.

This matter was reviewed by Deputy City Attorney Amy R. Webber on March 21, 2018.

#### TIMING CONSIDERATIONS

The hearing date of April 17, 2018, has been posted on the business location, with the applicant and property owners within 300 feet notified by mail.

#### FISCAL IMPACT

The following fees were collected with the application: Building Review \$22.45 and Zoning Review \$33.00 (Development Services), Police Investigation \$1,280.00 (Police Department), Mailing List \$90.00, and Temporary Permit \$400.00 (Financial Management Department).

The following fees will be collected if the application is approved: Business License Annual Tax \$355.25, Employee Rate \$18.45 per employee, and Annual Entertainment Regulatory Fee \$1,080.00 (Financial Management Department).

# **Recommended Conditions of Operation**

Hooched Up Ventures, LLC. DBA Boomer's 5456 E. Del Amo Blvd.

**Application for Entertainment With Dancing** 

The Department of Financial Management recommends approval of the Permit subject to the following conditions:

#### ١. STANDARD CONDITIONS OF OPERATION

- 1) The operation of the establishment shall be limited to those activities and elements expressly indicated on the permit application and approved by the City Council. Any change in the operation, which exceeds the conditions of the approved permit, will require that a new permit application be submitted to the City Council for their review and approval.
- Unless separately applied for, reviewed, and approved, no adult entertainment, as 2) defined by Section 21.15.110 of the LBMC, shall be conducted on the permitted premises.
- The establishment shall remain in compliance with all applicable sections of the Long Beach Noise Ordinance (LMBC Chapter 8.80).
- Due to the proximity of neighboring businesses and residences, all door(s) and windows shall be kept closed at all times during any entertainment, except in cases of emergency and to permit deliveries. Said door(s) is not to consist solely of a screen or ventilated security door. Sound shall not be audible beyond fifty feet (50') from the exterior of the premises in any direction. Outdoor amplified entertainment is prohibited.
- The permittee shall not allow employees to discard trash or beer bottles into the outside dumpster between the hours of 10:00 P.M. and 7:00 A.M.
- Deliveries to and from the premises shall be limited to the hours of 8:00 A.M. to 6) 10:00 P.M.
- The permittee shall provide a minimum of one (1) uniformed security guard during 7) all times that the entertainment activities are being conducted for crowds up to fifty (50) people. For crowds over fifty (50) people, the permittee shall provide a minimum of one (1) additional uniformed security guard per fifty (50) people. Patrons awaiting entry in a defined queue shall be counted toward the calculation of required security staffing levels.

The attire of each security guard shall clearly indicate the guard's affiliation with the establishment by means of a pin, shirt, or other visible form of identification. Should the permittee's operations give rise to a substantial increase in complaint/calls for police service, or trash left in the parking lot, the permittee shall increase security staff, implement the use of electronic metal detection equipment, increase outside RECOMMENDED CONDITIONS OF OPERATION

lighting, or make other changes to the premises or operation as the Chief of Police determines are necessary to protect the safety of the public.

- 8) Interior lighting shall be sufficient to make easily discernible the appearance and conduct of all persons and patrons inside the business.
- 9) The permittee shall take reasonable measures to prohibit and prevent the loitering of persons immediately outside any of the entrance/exit doors and the parking lot, at all times while open for business. This should be done by use of security guards and signage indicating words to the effect of, "Please respect our neighbors" or something similar.
- 10) At the conclusion of each event, the permittee shall take reasonable measures to ensure that exiting patrons walk directly to their vehicles, and not loiter in the front of the establishment, the parking lot or the immediate area.
- 11) The permittee shall be responsible for maintaining free of litter the premises and the area adjacent to the licensed premises over which they have control.
- 12) The permittee agrees to reimburse the City for all costs associated with excessive police services, as determined by the Chief of Police, required as the result of any incident or nuisance arising out of or in connection with the permittee's operations.
- 13) Current occupancy loads shall be posted at all times, and the permittee shall have an effective system to keep count of the number of occupants present at any given time and provide that information to public safety personnel upon request. (LBMC section 18.48.320).
- 14) Any graffiti painted or marked upon the premises, or on any adjacent area under the control of the licensee, shall be removed or painted over within 24 hours of being applied.
- 15) The business, or agents, shall not distribute any advertising matter such as signs, posters, or promotional cards, in or upon any public property, or in or on any vehicle in any such place in the City. Distribution of any advertising matter upon private property shall adhere to the following guidelines: By placing the same matter in a receptacle, clip, or other device designed or intended to receive advertising matter. The permittee shall keep all promoter contracts, including names, addresses, and phone numbers, on file at all times, and be available for inspection at any time.
- 16) The permittee shall install and maintain a video surveillance system that monitors no less than the front and rear of the business with full view of the public right-of-ways and any parking lot under the control of the permittee. The video system must be capable of delineating on playback the activity and physical features of persona and areas within the premises. Recordings shall be retained for a minimum of 30 days and be accessible via the Internet by the Long Beach Police Department. A Public Internet Protocol (IP) address and user name/password is also required to allow the Long Beach Police Department to view live and recorded video from these cameras over the internet. All video security cameras shall be installed to

the satisfaction of the Chief of Police, Director of Technology Services, and Director of Development Services. At the discretion of the Chief of Police, the permittee may be required to add additional video cameras.

- 17) The permittee shall ensure all employees attend an alcohol awareness class, such as the LEAD program offered by the Department of Alcoholic Beverage Control, within the first ninety (90) days of employment. In the event that the LEAD program class is not offered within this ninety day period, the permittee shall attend the next available class. Proof of completion shall be kept on file at the business and be available for inspection at any time.
- 18) The permittee shall maintain full compliance with all applicable laws, ABC laws, ordinances, and stated conditions. In the event of a conflict with the requirements of this permit, your conditional use permit, or your Alcoholic Beverage Control license, the more stringent regulation shall apply.

#### II. ADDITIONAL CONDITIONS OF OPERATION

- 1) Entertainment activities indicated on Page 9 of your entertainment application shall be restricted from 1:00 PM to 1:00 AM on Sunday, 7:00 PM to 1:00 AM Monday through Thursday, 7:00 PM to 2:00 AM on Friday, and 1:00 PM to 2:00 AM on Saturday.
- 2) No owner, operator or manager shall permit any person under the age of 21 years of age within the premises at any time.
- 3) The permittee shall ensure the security guard(s) monitor and check the adjacent property and parking lots on an hourly basis after 8:00 p.m. each night entertainment is provided. Security shall maintain order and prevent the unlawful consumption of alcohol and prevent any activity that would interfere with the quiet enjoyment of any nearby residential property.
- 4) Alcoholic beverages shall not be consumed on any property adjacent to the premises.
- III. In the event that any of the recommended conditions attached to any permit or license is in conflict, the permittee shall adhere to the strictest of the applicable conditions. In addition, please be advised that your permit is subject to administrative review every two years from the date this permit is issued. If grounds exist for modification, revocation, or suspension of the permit, a hearing will be held.



#### ATTENTION LICENSE APPLICANT

Business License Required (L.B.M.C. 3.80.210)

Under the Long Beach Municipal Code (Section 3.80.210), any person operating a business in the City of Long Beach is required to obtain a business license and pay an annual business license tax, prior to the operation of that business.

Term of License (L.B.M.C. 3.80.520)

A business license is valid for one (1) year from the date of issuance (unless otherwise noted) and must be renewed each year. A renewal notice is sent to the licensee ten (10) days prior to the due date, and the licensee has thirty (30) days to pay without penalty. If a notice is not received by the licensee, he/she is still responsible for payment by the due date. If the licensee changes his/her mailing address during the year, he/she should contact the Business License Section to report the change.

Penalties (L.B.M.C. 3.80.422)

A penalty equivalent to twenty-five percent (25%) of the payment due applies to all delinquent licenses unpaid after thirty (30) days from the due date. An additional ten percent (10%) penalty is added on the first day of the calendar month following the imposition of the twenty-five percent (25%) penalty if the tax remains unpaid, up to a maximum of one hundred percent (100%) of the tax due. The postmark will govern the determination of whether or not a tax payment is delinquent. A delinquent tax will be deemed a debt to the City, and the licensee shall be liable for legal action if it remains unpaid.

Multiple Businesses at one Location (L.B.M.C 3.80.420.6)

When more than one business activity is engaged in at the same location, and the activity falls into a classification other than that of the original license, the licensee is required to obtain an additional license for each different business activity. If the licensee has more than one business license at the same location, he/she may choose to pay for all employees on one license. If so, the licensee will pay for the employees on the license with the higher employee rate.

Definition of an Employee (L.B.M.C. 3.80.150)

For the purpose of Business License taxation in the City of Long Beach, an employee is defined as: Every person engaged in the operation or conduct of any business in Long Beach, whether as owner, member of the owner's family, partner, associate, agent, manager or solicitor, and every person employed or working in such business, whether full-time, part-time, permanent or temporary, for a wage, salary, commission or room and board. The owner of a sole proprietorship shall not be deemed to be an "employee" of the business.

Change of Location (L.B.M.C. 3.80.424)

Every person possessing a City of Long Beach Business License who changes the location of his place of business shall, prior to engaging in such a business at the new location, have the City endorse the new location on the license.

**Display of License (L.B.M.C. 3.80.425.5)** 

Every person having a license shall prominently display the license at the place of business. If the business is operated from a vehicle, an identifying decal issued by the City shall be affixed to the vehicle, and the business license shall be carried by the licensee.

Refunds Prior to Start of Business (L.B.M.C. 3.80.427.5.F)

Any application for refund must be made by the person entitled to the money within one year after payment of the money to the City. No refund shall be made of any moneys paid for the issuance or renewal of any license unless it is determined that such licensee has not engaged in, nor held himself out as being engaged in, such business or occupation at any time after the effective date of the license. The amount of the refund shall be the full amount of the license tax paid, less an amount determined by the Director of Financial Management, which shall cover the cost of investigation and issuance of the license.

#### Sales or Use Tax

Inspections (The business license application must be available on site at time of inspection).

When a business license inspection is scheduled, the business must be fully prepared to operate, and the business owner or operator must be on site for the entire scheduled time of inspection. If the business owner or operator is unprepared for or misses a scheduled business license inspection without giving a minimum of 24 hours notice to the appropriate City agency, a re-inspection fee will be assessed.







The Police Department recommends **approval** of this application for an Entertainment with Dancing Permit by Hooched Up Ventures, LLC, dba, Boomer's Cocktail Lounge, located at 5456 E. Del Amo Boulevard, subject to the conditions provided in the attached memorandum.

#### **Background**

Boomer's is located at 5456 Del Amo Boulevard and is owned and operated by Kevin Underwood. Boomer's is under new ownership, which is why a new application has been received. The previous owner had a valid Entertainment with Dancing Permit since June 1995.

In December 2017, Boomer's was issued a Type 48 (On-Sale General-Public Premises) Alcoholic Beverage Control (ABC) license, and, in November 2017, a business license/change of ownership for a Bar/Tavern/Lounge was issued by Business License Division.

On November 3, 2017, Kevin Underwood applied for an Entertainment with Dancing Permit requesting dancing by patrons, dancing by performers, live music by more than two performers, live and recorded amplified music, a disc jockey and karaoke Sunday, 1:00 p.m. to 1:00 a.m., Monday through Thursday, 7:00 p.m. to 1:00 a.m., Friday, 7:00 p.m. to 2:00 a.m., and Saturday, 1:00 p.m. to 2:00 a.m.

#### Crime Analysis

As part of the review process by the Police Department, calls for service, incident reports and arrests were evaluated between November 3, 2016, and February 13, 2018. There were three calls for service, one incident report and one arrest attributable to the business.

The calls for service consisted of one audible burglary alarm, one call for verbal dispute inside, involving Boomer's bartender and patron, and one stabbing that occurred in the parking lot between Boomer's patrons.

The incident report and arrest were both related to the same incident. Vice Investigations conducted an inspection of the establishment and cited the business for not posting their ABC/Business licenses. The incident occurred in September 2011, prior to the current owner officially taking over the establishment.

#### Vice Investigations

As part of this investigation, Vice detectives went to the location and observed eight residences within 100 feet of the establishment. Detectives were able to make contact with one of the residents, who stated she is not opposed to the approval of entertainment activities at the establishment. Six residents were not home during the time detectives responded, but letters were left, requesting they call and speak with detectives to share their concerns.

Detectives also went to this location in an undercover capacity on two occasions. While there, they saw approximately 25 people inside the establishment, watching a live band perform, drinking beer and socializing. The live band could not be heard from outside of the establishment. Detectives did not observe any violations while inside the establishment.

Vice detectives met with the owner and head of security at the establishment. They discussed the proposed entertainment activities, where entertainment activities will take place and the conditions the Police Department will recommend for the Entertainment with Dancing Permit.

#### **Patrol Division**

East Division Patrol Commander Erik Herzog was contacted for an opinion regarding the issuance of this permit. He stated he has not seen any problems with this location and does not foresee the approval having a negative impact on patrol resources. Commander Herzog does not have any objection to the issuance of an Entertainment with Dancing Permit.

#### Recommendation

Based upon the crime analysis, Vice Section's investigations, resident contacts and the East Division Patrol Commander's recommendation, the Long Beach Police Department has determined the public's peace, safety and welfare would not be adversely impacted by the issuance of this permit, provided the appropriate conditions are imposed and observed by the applicant.

APPLICATION FOR AN ENTERTAINMENT WITH DANCING PERMIT AT BOOMER'S COCKTAIL LOUNGE - 5456 E. DEL AMO BOULEVARD

In response to your request for a recommendation regarding the above-named permit application for Entertainment with Dancing, the Police Department recommends approval of an Entertainment with Dancing Permit, subject to the following conditions:

Boomer's is located on E. Del Amo Boulevard, between Bellflower Boulevard and Clark Avenue, in the City of Long Beach. Hooched Up Ventures, LLC., dba Boomer's Cocktail Lounge, is owned and operated by Kevin Underwood.

On February 14, 1995, the City Council approved a type 48 (On Sale General-Public Premises) Alcoholic Beverage Control (ABC) license. On November 3, 2017, Kevin Underwood applied for an Entertainment with Dancing Permit requesting dancing by patrons, dancing by performers, live music by more than two performers, amplified music (live), amplified music (recorded), a disc jockey and karaoke. The hours of entertainment will be Sunday, 1:00 p.m. to 1:00 a.m., Monday through Thursday, 7:00 p.m. to 1:00 a.m., Friday, 7:00 p.m. to 1:00 a.m., and Saturday, 1:00 p.m. to 2:00 a.m.

Based upon the crime analysis, Vice Section's investigation and the East Division Patrol Commander's recommendation, the Long Beach Police Department has determined the public peace, safety and welfare would not be adversely impacted by the issuance of this permit, provided the appropriate conditions are imposed and observed by the applicant. The Police Department recommends approval of an Entertainment with Dancing Permit.

#### **CONDITIONS OF OPERATION**

- 1) The operation of the establishment shall be limited to those activities and elements expressly indicated on the permit application and approved by the City Council. Any change in the operation, which exceeds the conditions of the approved permit, will require that a new permit application be submitted to the City Council for its review and approval.
- Unless separately applied for, reviewed and approved, no adult entertainment, as defined by Section 21.15.110 LBMC, shall be conducted on the permitted premises.

- 3) Entertainment activities, as indicated on Page 9 of your Entertainment Application shall be restricted to Sunday, 1:00 p.m. to 1:00 a.m., Monday through Thursday, 7:00 p.m. to 1:00 a.m., Friday, 7:00 p.m. to 2:00 a.m., and Saturday, 1:00 p.m. to 2:00 a.m.
- 4) The establishment shall remain in compliance with all sections of the Long Beach Noise Ordinance (LBMC Chapter 8.80).
- Due to the proximity of neighboring businesses and residences, all doors and windows shall be kept closed at all times during any musical entertainment, except in cases of emergency and to permit deliveries. Said doors shall not consist solely of screens or ventilated security doors. Sound shall not be audible beyond 50 feet from the exterior of the premises, in any direction.
- The permittee shall not allow employees to discard trash or beer bottles into the outside dumpster between the hours of 10:00 p.m. and 7:00 a.m.
- 7) The permittee shall be responsible for maintaining free of litter the premises and the area adjacent to the licensed premises, over which he has control.
- 8) Any graffiti painted or marked upon the premises, or on any adjacent area under the control of the licensee, shall be removed or painted over within 24 hours of being applied.
- 9) No owner, operator or manager shall permit any person under the age of 21 years of age within the premises at any time.
- 10) Interior lighting shall be sufficient to make easily discernible the appearance and conduct of all persons and patrons inside the business.
- 11) The permittee shall provide a minimum of one licensed security guard during all times the entertainment activities are being conducted for crowds up to 50 people. For crowds over 50 people, the permittee shall provide a minimum of one additional security guard per 50 people. Patrons awaiting entry in a defined queue shall be counted toward the calculation of required security staffing levels.

The attire of each security guard shall clearly indicate the guard's affiliation with the establishment by means of a pin, shirt or other visible form of identification. Should the permittee's operations give rise to a substantial increase in complaint/calls for police service or trash left in the parking lot, the permittee shall increase security staff, implement the use of electronic metal detection equipment, increase outside lighting or make other changes to the premises or operation as the Chief of Police determines are necessary to protect the safety of the public.

- 12) At the conclusion of each event, the permittee shall take reasonable measures to ensure that exiting patrons walk directly to their vehicles and not loiter in the parking lot, alley or immediate area.
- 13) The permittee shall ensure security guard(s) monitor and check the adjacent property and parking lots on an hourly basis after 8:00 p.m. each night entertainment is provided. Security shall maintain order and prevent the unlawful consumption of alcohol and prevent any activity that would interfere with the quiet enjoyment of any nearby residential property.
- 14) The permittee shall take reasonable measures to prohibit and prevent the loitering of persons immediately outside any of the entrance/exit doors and the parking lot at all times while open for business. This should be done by utilizing security guards and signage with verbiage such as, "Please respect our neighbors."
- 15) If any trash, noise or disturbance complaints in the parking lot and/or surrounding area of the business can be attributed to the operation of said business, the Long Beach Police Department can determine and impose requirements for security officer(s) to routinely monitor and handle these problems
- 16) Current occupancy load shall be posted at all times, and the permittee shall have an effective system to keep count of the number of occupants present at any given time. This information shall be provided to public safety personnel upon request.
- 17) The permittee agrees to reimburse the City for all costs associated with excessive police services, as determined by the Chief of Police, required as the result of any incident or nuisance arising out of or in connection with the permittee's operations.
- 18) Alcoholic beverages shall not be consumed on any property adjacent to the premises.
- 19) Boomer's Cocktail Lounge, or its agents, shall not distribute any advertising matter, such as signs, posters or promotional cards, in or upon any public property, any vehicle or in any other such place in the City of Long Beach. Distribution of any advertising matter upon private property shall adhere to the following guidelines: By placing the same matter in a receptacle, cli, or other device designed or intended to receive advertising matter. The permittee shall keep all promoter contracts, including names, addresses and phone numbers, on file at all times and be available for inspection at any time.

- 20) The permittee shall maintain full compliance with all applicable laws, ABC laws, ordinances, and stated conditions. In the event of a conflict between the requirements of this permit, your conditional use permit, or your Alcoholic Beverage Control license, the more stringent regulation shall apply.
- 21) The permittee shall ensure that all employees attend an alcohol awareness Class, such as TIPS or LEAD, within the first 90 days of employment. The permittee shall keep employee's proof of completion on file and be available for inspection at any time.
- The permittee shall install and maintain a video surveillance system that monitors no less than the front and rear of the business, with full view of the public rights-of-way and any parking lot under the control of the permittee. The video system must be capable of delineating on playback the activity and physical features of persons and areas within the premises. Recordings shall be retained for a minimum of 30 days and be accessible via the Internet by the Long Beach Police Department. A Public Internet Protocol (IP) address and user name/password is also required to allow the Long Beach Police Department to view live and recorded video from these cameras over the Internet. All video security cameras shall be installed to the satisfaction of the Chief of Police, Director of Technology Services and Director of Development Services. At the discretion of the Chief of Police, the permittee may be required to add additional video cameras.
