FIRST AMENDMENT TO AGREEMENT NO. 34464

34464

THIS FIRST AMENDMENT TO AGREEMENT NO. 34464 is made and entered, in duplicate, as of October 13, 2017 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on November 22, 2016, by and between ADVANCED PROBLEM SOLVING, LLC, a California limited liability company, ("Contractor"), with a place of business at 411 University Circle, Claremont, California 91711, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with the Los Angeles Area Fire Chiefs Association (LAAFCA) Regional Training Video and Curriculum Development ("Project"); and

WHEREAS, the parties entered Agreement No. 34464 ("Agreement") whereby Contractor agreed to provide these services; and

WHEREAS, the parties desire to revise the scope and term of the Agreement;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

1. Section 1.A. of Agreement No. 34464 is hereby amended to read as follows:

"1. SCOPE OF WORK OR SERVICES.

A. Contractor shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed ONE MILLION EIGHT HUNDRED THOUSAND DOLLARS (\$1,800,000), at the rates or charges shown in Exhibit "B".

2. Section 2. of Agreement No. 34464 is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on January 9, 2017, and shall terminate at 11:59 p.m. on January 8, 2020, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."

3. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34464 are ratified and confirmed and shall remain in full force and effect.
