## ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE LONG BEACH MUNICIPAL CODE BY AMENDING SECTION 10.22.080 BY ADDING SUBSECTION BB RELATING TO PARKING VEHICLES FOR SALE

WHEREAS, the City has received numerous complaints from citizens regarding the parking of vehicles with "For Sale" signs on Bayshore Avenue between Appian Way and 2<sup>nd</sup> Street, on 2<sup>nd</sup> Street between Bayshore Avenue and Naples Plaza and on Colorado Street between Nieto Avenue and Bellflower Boulevard; and

WHEREAS, with the increase of vehicles parking with "for sale" signs on them in the areas described above, such activity is creating unsafe traffic conditions because motorists interrupt traffic flow to stop or slow down to observe the vehicles displaying "for sale" signs which creates the potential for traffic collisions.

NOW THEREFORE, the City Council of the City of Long Beach ordains as follows:

Section 1. Section 10.22.080 of the Long Beach Municipal Code is hereby amended by adding Subsection BB to read as follows:

BB. Bayshore Avenue between Appian Way and 2<sup>nd</sup> Street, on 2<sup>nd</sup> Street between Bayshore Avenue and Naples Plaza and on Colorado Street between Nieto Avenue and Bellflower Boulevard.

Sec. 2. The City Clerk shall certify to the passage of this ordinance by the City Council and cause the same to be posted in three conspicuous places in the City of Long Beach, and it shall take effect on the thirty-first day after it is approved by the
