FIRST AMENDMENT TO AGREEMENT NO. 35594

35594

THIS FIRST AMENDMENT TO AGREEMENT NO. 35594 is made and entered, as of July 6, 2023 for reference purposes only, pursuant to Resolution No. RES-20-0079 adopted by the City Council of the City of Long Beach at its meeting on July 14, 2020, by and between FASTENAL COMPANY, a Minnesota corporation ("Contractor"), whose address is 2001 Theurer Blvd., Winona, Minnesota 55987, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, pursuant to Resolution No, RES-20-0079, City and Contractor (the "Parties") entered into Agreement No. 35594 (the "Agreement") whereby Contractor agreed to provide to the City fasteners, miscellaneous hardware, and heating, ventilation, and air conditioning parts and supplies through the Omnia Partners Agreement between the University of California and Fastenal Company, Agreement No. 2018.000208; and

WHEREAS, Agreement No. 2018.000208 has been extended to June 30, 2025; and

WHEREAS, the Parties desire to extend the term of the Agreement to June 30, 2025;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.D of the Agreement is hereby amended to read as follows:

"D. The term of this Agreement shall commence at midnight on September 1, 2020, and shall terminate at 11:59 p.m. on June 30, 2025. The Parties have the option to extend the term for as long as the Omnia Partners contract is in effect, at the discretion of the City Manager."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35594 are ratified and confirmed and shall remain in full force and effect.
