A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO PURCHASE COMMERCIAL TRASH CONTAINERS THROUGH THE BLANKET PURCHASE ORDER BETWEEN THE CITY OF SANTA MONICA AND CONSOLIDATED FABRICATORS CORPORATION

WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City desires to purchase commercial trash containers ("Containers"); and

WHEREAS, the City of Santa Monica has a blanket purchase order for the purchase of these Containers, Blanket Purchase Order No. 27288 ("Santa Monica PO"); and

WHEREAS, the City's participation in the Santa Monica PO will facilitate acquisition of these Containers as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the Santa Monica PO considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated herein by this reference.

in an amount not to exceed O	ne Hundred Eighty Tho	ousand Dollars (\$180,000) inclu	ding
tax and shipping, for a period	of one (1) year, extend	ing until the warranty on the	
commercial trash containers e	xpires.		
Section 3. Th	is resolution shall take	effect immediately upon its add	ption
by the City Council, and the C	ity Clerk shall certify th	e vote adopting this resolution.
