THIRD AMENDMENT TO AGREEMENT NO. 35373

THIS THIRD AMENDMENT TO AGREEMENT NO. 35373 is made and entered, as of October 10, 2022 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on May 21, 2019, by and between R.S. CAMPBELL CONSULTING, INC., a California corporation (“Consultant”), with a place of business at 1161 Marine View Dr., Vista, CA 92081, and the CITY OF LONG BEACH, a municipal corporation (“City”).

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with professional services supporting the deployment of the proprietary software system Envision Connect (EC) (“Project”); and

WHEREAS, City and Consultant (the “Parties”) entered into Agreement No. 35373 (the “Agreement”) whereby Consultant agreed to provide these services; and

WHEREAS, the Parties desire to add to amend the Agreement to reflect the aggregate contract amount for all terms and to attach an updated rate sheet;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows.
  - A. Consultant shall furnish specialized services more particularly described in Exhibit “A”, attached to the Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed a total Agreement amount of Five Hundred Twelve Thousand Fifty Dollars (\$512,050), at the rates or charges shown in Exhibit “B-1.”
2. The Rates contained in Exhibit “B” to the Agreement are hereby amended and replaced by Exhibit “B-1”, attached hereto and incorporated herein.
3. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35373 are ratified and confirmed and shall remain in full force and effect.

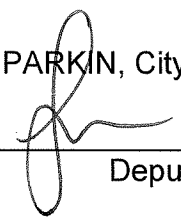
