RESOLUTION NO. RES-09-0066

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY TO EXECUTE AN AGREEMENT TO PURCHASE LOCAL TELEPHONE AND DATA COMMUNICATION SERVICES THROUGH THE CONTRACTS BETWEEN VERIZON NETWORK BUSINESS SERVICES AND THE STATE OF CALIFORNIA

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City to participate in joint cooperative purchasing of services, supplies, materials, equipment, and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City of Long Beach desires to purchase local telephone and data communication services from Verizon Network Business Services; and

WHEREAS, the State of California ("State") has a contract for the purchase of Verizon Network Business Services known as Price Agreement Nos. 5-06-58-20 (DTS06E1392) AND 5-06-58-21 (DTS 06E1393) ("Price Contracts"); and

WHEREAS, City's participation in the Price Contracts will facilitate acquisition of local telephone and data communication services as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the Price Contracts considerably more funds would be required;

NOW, THEREFORE, the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. The City Manager of the City of Long Beach is hereby

1 authorized to enter into an agreement with Verizon Business Network Services for the
2 purchase of local telephone and data communication services as ordered by the City of
3 Long Beach, pursuant to the Price Contracts. The purchase by the City of Long Beach
4 shall be on the same terms and conditions afforded to the State, in an amount not to
5 exceed One Million Four Hundred Seventy Thousand Seven Hundred Dollars
6 (\$1,470,700.00) for a period of three (3) years with options for two (2) additional periods
7 of one (1) year each.


8 Section 3. This resolution shall take effect immediately on its adoption by
9 the City Council, and the City Clerk shall certify the vote adopting this resolution.
