

1 FIRST AMENDMENT TO AGREEMENT NO. 35904

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 35904 is made and
4 entered, in duplicate, as of March 21, 2023, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on April
6 13, 2021, by and between VECTOR RESOURCES, INC. DBA VECTORUSA, a California
7 corporation ("Consultant"), with a place of business at 20917 Higgins Court, Torrance,
8 California 90501, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 35904 (the "Agreement") whereby Consultant agreed to provide as-needed Citywide data,
11 telephone, and fiber optic structured cabling; and

12 WHEREAS, the Parties desire to extend the contract for one (1) additional
13 one-year period and increase the total annual contract amount to \$800,000;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
15 conditions herein contained, the Parties agree as follows:

16 1. Section 1.A. of the Agreement is hereby amended to read as follows.

17 "A. Consultant shall furnish specialized services more particularly
18 described in Exhibit "A", attached to this Agreement and incorporated by this reference, in
19 accordance with the standards of the profession, and City shall pay for these services in
20 the manner described below, in an annual amount not to exceed Eight Hundred
21 Thousand Dollars (\$800,000), at the rates or charges shown in Exhibit "B".

22 2. Section 2. of the Agreement is hereby amended to read as follows:

23 "TERM. The term of this Agreement shall commence at midnight on May 1,
24 2021, and shall terminate at 11:59 p.m. on April 30, 2024, unless sooner terminated as
25 provided in this Agreement, or unless the services or the Project is completed sooner. The
26 term may be extended for two (2) additional one-year periods, at the discretion of the City
27 Manager."

28 3. Except as expressly modified herein, all of the terms and conditions

1 contained in Agreement No. 35904 are ratified and confirmed and shall remain in full force
2 and effect.


