SEVENTH AMENDMENT TO AGREEMENT NO. 33453

33453

THIS SEVENTH AMENDMENT TO AGREEMENT NO. 33453 is made and entered, in duplicate, as of October 24, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on October 15, 2019, by and between BUNNELL ENTERPRISES, INC. DBA TOTAL NETWORK SOLUTIONS, a California corporation, located at 5150 E. Pacific Coast Highway, Suite 530, Long Beach, CA 90804 ("Contractor"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 33453 (the "Agreement") whereby Contractor agreed to provide professional and technical services for information technology projects and systems on an as-needed basis; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to increase the total not to exceed amount to \$150,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to increase the total not to exceed amount to \$350,000 and extend the term to January 22, 2017; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to increase the total not to exceed amount to \$500,000; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to increase the total not to exceed amount to \$700,000 and extend the term to January 22, 2018; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to increase the total not to exceed amount to \$800,000 and extend the term to January 22, 2019; and

WHEREAS, the Parties entered into a Sixth Amendment to the Agreement to increase the total not to exceed amount to \$900,000 and extend the term to October 22, 2019; and

1 WHEREAS, the Parties desire to add \$50,000 to the Agreement for a total
2 not to exceed amount of \$950,000 and extend the term to March 22, 2020;

3 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
4 conditions herein contained, the Parties agree as follows:

5 1. Section 1.A of the Agreement is hereby amended to read as follows:

6 “A. Contractor shall furnish specialized services more particularly
7 described in Exhibit “A”, attached to the Agreement and incorporated by this
8 reference, in accordance with the standards of the profession, and City shall pay
9 for these services in the manner described below, a total not to exceed contract
10 amount of Nine Hundred Fifty Thousand Dollars (\$950,000), at the rates or
11 charges shown in Exhibit “A”.”

12 2. Section 2 of the Agreement is hereby amended to read as follows:

13 “2. TERM. The term of this Agreement shall commence on April 22, 2014,
14 and shall terminate on March 22, 2020, unless sooner terminated as provided in this
15 Agreement, or unless the services or the Project is completed sooner.”

16 3. Except as expressly modified herein, all of the terms and conditions
17 contained in Agreement No. 33453 are ratified and confirmed and shall remain in full force
18 and effect.
