RESOLUTION NO. RES-17-0049

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE NATURAL GAS TRANSPORTATION/SERVICE AGREEMENTS AND ANY AMENDMENTS THERETO, BETWEEN THE CITY AND SCHEDULES 5, 7 AND 9 TRANSPORTATION CUSTOMERS OF THE LONG BEACH GAS & OIL DEPARTMENT

WHEREAS, the City of Long Beach, acting through the Long Beach Gas & Oil Department (LBGO), permits certain customer classifications to procure natural gas supply from third-party marketers and use the City of Long Beach's pipeline systems to transport this gas to end-use facilities; and

WHEREAS, customers that are permitted to acquire natural gas supplies from third-parties are classified under Gas Rate Schedule 5, 7 and 9; and

WHEREAS, while these customers are not charged for the natural gas commodity, they are charged transmission rates that correspond to their rate classification; and

WHEREAS, LBGO currently has Customer Natural Gas Transportation/Service Agreements with ten customers (National Gypsum, Long Beach Memorial Hospital, Toyota, Asphalt Products, American Textile, Community Hospital, St. Mary's Hospital, Bloom Energy, California State University Long Beach, and Home Depot) and these agreements are scheduled to expire on July 31, 2017;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The City Manager, or designee, is authorized to execute Customer Natural Gas Transportation/Service Agreements and any amendments thereto,
