THIRD AMENDMENT TO AGREEMENT NO. 35405

THIS THIRD AMENDMENT TO AGREEMENT NO. 35405 is made and entered, in duplicate, as of March 9, 2021, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on August 13, 2019, by and between POLYTECHNIQUE ENVIRONMENTAL, INC., a California corporation ("Consultant"), with a place of business at 13337 South Street, #144, Cerritos, California 90703, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35405 (the "Agreement") whereby Consultant agreed to provide on-call environmental program support; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$50,000 for a total not to exceed amount of \$75,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$80,000 for a total not to exceed amount of \$155,000; and

WHEREAS, the Parties now desire to add \$75,000 to the Agreement;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, in an amount not to exceed Two Hundred Thirty Thousand Dollars (\$230,000), at the rates or charges shown in Exhibit "B"."
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35405 are ratified and confirmed and shall remain in full force and effect.
