7 to increase the total not to exceed amount to \$4,500,000; and

8 WHEREAS, the Parties entered into an Eleventh Amendment to the
9 Agreement to increase the total not to exceed amount to \$5,000,000 and extend the term
10 to October 22, 2019; and

11 WHEREAS, the Parties entered into a Twelfth Amendment to the Agreement
12 to increase the total not to exceed amount to \$5,595,000; and

13 WHEREAS, the Parties entered into a Thirteenth Amendment to the
14 Agreement to increase the total not to exceed amount to \$6,000,000 and extend the term
15 to March 22, 2020; and

16 WHEREAS, the Parties desire to add \$1,000,000 to the Agreement for a total
17 not to exceed amount of \$7,000,000;

18 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
19 conditions herein contained, the Parties agree as follows:

20 1. Section 1.A of the Agreement is hereby amended to read as follows:

21 "A. Consultant shall furnish specialized services more particularly
22 described in Exhibit "A," attached to the Agreement and incorporated by this
23 reference, in accordance with the standards of the profession, and City shall pay
24 for these services in the manner described below, a total not to exceed contract
25 amount of Seven Million Dollars (\$7,000,000), at the rates or charges shown in
26 Exhibit "A"."

27 2. Except as expressly modified herein, all of the terms and conditions
28 contained in Agreement No. 33392 are ratified and confirmed and shall remain in full force
