
DISCUSSION:

RECOMMENDATION:

Recommendation to authorize the City Attorney to submit three Stipulations with Request for Award for approval by the Workers' Compensation Appeals Board, and if so approved, authority to pay 1) \$22,153.75, 2) \$20,926.25, and 3) \$13,680.00 in compliance with the Appeals Board Order for Maurice Weiner.

DISCUSSION:

Maurice Weiner has made a claim for injuries allegedly sustained in the course of his employment with the City of Long Beach. The Economic Development and Finance Committee on July 9, 2013, approved the submission to the Workers' Compensation Appeals Board of three Stipulations with Request for Award by the City and Maurice Weiner, based upon a 1) 29 percent disability, with provisions for future medical treatment, 2) 19 percent disability, with provisions for future medical treatment, and 3) 23 percent permanent disability, with provision for future medical treatment as may be necessary.
