WHEREAS, City and Contractor (the "Parties") entered into Contract No. 34403 whereby Contractor agreed to perform the work described in Project Plans and Specifications No. R-7051, Improvements to the Garage (Lot A) at the Long Beach Airport in the City of Long Beach, California; and

WHEREAS, the Parties desire to increase the Contract amount by \$26,149 for a total not-to-exceed amount of \$4,942,373;

NOW, THEREFORE, in consideration of the mutual terms, covenants and conditions contained herein, the Parties agree as follows:

- 1. Section 2.A. of Contract No. 34403 is hereby amended to read as follows:
 - "A. City shall pay to Contractor the amount(s) for materials and work identified in Contractor's "Bid for Improvements to the Garage (Lot A) at the Long Beach Airport in the City of Long Beach, California," attached hereto as Exhibit "A", provided, however, that the total compensation to Contractor shall not exceed the maximum cumulative amount of Four Million Nine Hundred Forty-Two Thousand Three Hundred Seventy-Three Dollars (\$4,942,373) for the estimated quantities established in the Bid, subject to additions or deductions as provided in the Contract Documents."
- 2. Except as expressly modified herein, all of the terms and conditions contained in Contract No. 34403 are ratified and confirmed and shall remain in full force
