1 EIGHTH AMENDMENT TO AGREEMENT NO. 34316

3 THIS EIGHTH AMENDMENT TO AGREEMENT NO. 34316 is made and
4 entered, in duplicate, as of March 11, 2020, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on March
6 10, 2020, by and between MACIAS GINI & O'CONNELL LLP, a California limited liability
7 partnership fka INTELLIBRIDGE PARTNERS LLC, a California limited liability company
8 ("Consultant"), with a place of business at 3000 S Street, Suite 300, Sacramento, California
9 95816, and the CITY OF LONG BEACH, a municipal corporation ("City").

10 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
11 34316 (the "Agreement") whereby Consultant agreed to provide as-needed professional
12 and technical services; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to
14 extend the term to January 22, 2018 and increase the total amount not to exceed to Four
15 Hundred Thousand Dollars (\$400,000); and

16 WHEREAS, the Parties entered into a Second Amendment to the Agreement
17 to increase the total not to exceed amount to \$800,000; and

18 WHEREAS, the Parties entered into a Third Amendment to the Agreement
19 to increase the total amount not to exceed to \$1,200,000 and extend the term to January
20 22, 2019; and

21 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
22 to increase the total not to exceed amount to \$1,600,000; and

23 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to
24 increase the total not to exceed amount to \$2,000,000 and extend the term to May 22,
25 2019; and

26 WHEREAS, the Parties entered into a Sixth Amendment to the Agreement
27 to increase the total not to exceed the amount to \$2,500,000 and extend the term to
28 October 22, 2019; and

1 WHEREAS, the Parties entered into a Seventh Amendment to the
2 Agreement to extend the term to March 22, 2020; and

3 WHEREAS, the Parties desire to decrease the Agreement by \$155,000 for a
4 total not to exceed amount of \$2,345,000 and extend the term to July 22, 2020;

5 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
6 conditions herein contained, the Parties agree as follows:

7 1. Section 1.A. of the Agreement is hereby amended to read as follows:
8 “A. Consultant shall furnish specialized services more particularly
9 described in Exhibit “A”, attached to this Agreement and incorporated by this
10 reference, in accordance with the standards of the profession, and City shall pay for
11 these services in the manner described below, not to exceed Two Million Three
12 Hundred Forty-Five Thousand Dollars (\$2,345,000), at the rates or charges shown
13 in Exhibit “B”.”

14 2. Section 2 of the Agreement is hereby amended to read as follows:
15 “2. TERM. The term of this Agreement shall commence at midnight on
16 January 1, 2016, and shall terminate at 11:59 p.m. on July 22, 2020, unless sooner
17 terminated as provided in this Agreement, or unless the services or the Project is
18 completed sooner.”

19 3. Except as expressly modified herein, all of the terms and conditions
20 contained in Agreement No. 34316 are ratified and confirmed and shall remain in full force
21 and effect.
