#### PART 1 REASON FOR CHANGE

- 1.1 Change order required for field conditions that where significantly different than shown on the project plans, at the intersection of 6<sup>th</sup> St. and Park Ave., which necessitated time and materials tracking of labor, materials and equipment.
- 1.2 Change order required for placing and grading crushed miscellaneous base efforts, at 6<sup>th</sup> St. and Park Ave. and directly related to item 1.1, which necessitated time and materials tracking of labor, materials and equipment.
- 1.3 Change order required changed work for irrigation connection to City water main at the intersection of 6<sup>th</sup> St. and Havana Ave. for trench excavation, exposing existing water line, protecting and replacing excavated materials, and full depth asphalt concrete trench paving; which necessitated time and materials tracking of labor, materials and equipment.
- 1.4 The Change Order for irrigation connection to City water main at the intersections of 6<sup>th</sup> St. at Ultimo and Santiago Ave will be moved to Change Order # 02.
- 1.5 Change order required changed work for irrigation connection to City water main, at the intersections of 6<sup>th</sup> St. at Obispo, Temple and Molino Ave., for trench excavation, exposing existing water line, protecting and replacing excavated materials, and full depth asphalt concrete trench paving; which necessitated time and materials tracking of labor, materials and equipment.
- 1.6 Change order required for changed work of providing arrow board and changeable message board signs that were omitted from the bid documents; which necessitated time and materials tracking of labor, materials and equipment.
- 1.7 Change order required for changed work of providing water filled k-rail traffic control devices at 6<sup>th</sup> St. and Park Ave. that were omitted from the bid documents; which necessitated time and materials tracking of labor, materials and equipment.
- 1.8 Change order required for changed work of maintaining water quality protective measures (BMPs) for contaminated soils excavated from 6<sup>th</sup> St. and Park Ave., directly related to item 1.1, and temporarily stockpiled at the Long Beach Airport yard until appropriate disposal approvals could be obtained; which necessitated time and materials tracking of labor, materials and equipment.
- 1.9 Change order required for field conditions that where significantly different than shown on the project plans, at the intersection of 6<sup>th</sup> St. and Roswell Ave., which necessitated time and materials tracking of labor, materials and equipment.
- 1.10 Change order required for field conditions that where significantly different than shown on the project plans, at the intersections of 6<sup>th</sup> St. at Termino, Molino, Grand, and Obispo Ave., which necessitated time and materials tracking of labor, materials and equipment.
- 1.11 Change order required for changed work for irrigation connection to City water main, at the intersection of 6<sup>th</sup> St. at Termino Ave., for trench excavation and exposing existing water line, which necessitated time and materials tracking of labor, materials and equipment.
- 1.12 The Change Order for removing temporarily stockpiled contaminated soils will be moved to Change Order # 02.
- 1.13 Change order required for field conditions that where significantly different than shown on the project plans, at the 6<sup>th</sup> St. bike trail, which necessitated time and materials tracking of labor, materials and equipment.
- 1.14 Change order required for changed work for irrigation connection to City water main, at the intersections of 6<sup>th</sup> St. at Orizaba, Loma, and Grand Ave., for trench excavation and exposing existing water line, which necessitated time and materials tracking of labor.

- 1.15 Change order required for field conditions that where significantly different than shown on the project plans, at the intersection of 6<sup>th</sup> St. at Roswell Ave., which necessitated time and materials tracking of labor, materials and equipment.
- 1.16 Change order required for field conditions that where significantly different than shown on the project plans, at the intersection of 6<sup>th</sup> St. at Roswell Ave., which necessitated time and materials tracking of labor, materials and equipment.
- 1.17 Change order required for field conditions that where significantly different than shown on the project plans, at the intersections of 6<sup>th</sup> St. at Roswell, Temple, Molino, Obispo, Orizaba, Loma, Termino, Grand, Havana, Santiago, Flint, Ultimo Ave., which necessitated time and materials tracking of labor, materials and equipment.
- 1.18 Change order required for field conditions that where significantly different than shown on the project plans, at the intersections of 6<sup>th</sup> St. at Termino and Grand Ave., which necessitated time and materials tracking of labor, materials and equipment.
- 1.19 Change order required for field conditions that where significantly different than shown on the project plans, at the intersections of 6<sup>th</sup> St. at Roswell, Temple, Molino, Obispo, Orizaba, Loma, Termino, Grand, Havana, Santiago, Flint, Ultimo Ave., which necessitated a negotiated price in lieu of time and materials tracking of labor, materials and equipment.

#### PART 2 DESCRIPTION OF CHANGE

- 2.1 The plans indicated the street pavement structural section consisted of asphalt concrete (AC) over aggregate base over subgrade soils. Actual pavement structural section consisted of AC over pavement reinforcing fabric over Portland Cement Concrete (PCC) over subgrade soils. The subgrade soils were saturated clay which was unsuitable for compaction and required over-excavation, geogrid reinforcing fabric and additional crushed miscellaneous base (CMB) to stabilize the subgrade area. The changed conditions required changes to the contractor's means and methods of construction.
- 2.2 Additional efforts to place and grade CMB at the intersection of 6<sup>th</sup> St. and Park Ave. in order to achieve a stable subgrade at the proper grade for final pavement.
- 2.3 The plans indicated irrigation equipment was to be located in the parkway behind the curb and gutter, at the 6th St. and Havana Ave. intersection, with irrigation lines extending from the City water main to the irrigation equipment and to the intersection traffic circle. The agreed changed location for the irrigation equipment was into the intersection traffic circle; which shortened irrigation lines and placed the water meter in the traffic circle. The contractor worked in collaboration with the Water Department to minimize work efforts and public inconvenience.
- 2.4 The Change Order for irrigation connection to City water main at the intersections of 6th St. at Ultimo and Santiago Ave will be moved to Change Order # 02.
- 2.5 The plans indicated irrigation equipment was to be located in the parkway behind the curb and gutter, at intersections of 6<sup>th</sup> St. at Obispo, Temple and Molino Ave., with irrigation lines extending from the City water main to the irrigation equipment and to the intersection traffic circle. The agreed changed location for the irrigation equipment was into the intersection traffic circle; which shortened irrigation lines and placed the water meter in the traffic circle. The contractor worked in collaboration with the Water Department to minimize work efforts and public inconvenience.
- 2.6 Additional efforts to place and maintain arrow board and changeable message board signs for the 6<sup>th</sup> St. Bike Blvd. project from 7/28/2017 to 11/3/2017 in order to achieve the City's standards for temporary traffic control and project messaging.
- 2.7 Additional efforts to place and maintain water filled k-rail traffic control devices for the 6<sup>th</sup> St. Park Ave. project area from 8/29/2017 to 10/4/2017 in order to achieve the City's standards for temporary traffic control and pedestrian safety.
- 2.8 Additional efforts to place and maintain BMPs for temporarily stockpiled contaminated soils placed at the Long Beach Airport yard in order to achieve the City's water quality protective measures.
- 2.9 The plans indicated the size and location of intersection traffic circles that were subsequently changed in the field at the direction of the City. The contractor performed pavement sawcutting and removal as directed by the City and additional removals were requested by the design engineer. The design engineer's requested changes were approved and required additional efforts by the contractor and changes to the contractor's means and methods of construction.
- 2.10 The plans indicated the street pavement structural section consisted of asphalt concrete (AC) over aggregate base over subgrade soils. Actual pavement structural section consisted of

Portland Cement Concrete (PCC) over subgrade soils. The contractor removed pavement and constructed traffic circles as directed. However, the remaining slot trenches required placement of PCC pavement to restore the pavement section. The changed conditions required changes to the contractor's means and methods of construction.

- 2.11 The plans indicated irrigation equipment was to be located in the parkway behind the curb and gutter, at intersection of 6<sup>th</sup> St. at Termino Ave., with irrigation lines extending from the City water main to the irrigation equipment and to the intersection traffic circle. The agreed changed location for the irrigation equipment was into the intersection traffic circle; which shortened irrigation lines and placed the water meter in the traffic circle. The contractor worked in collaboration with the Water Department to minimize work efforts and public inconvenience.
- 2.12 The Change Order for removing temporarily stockpiled contaminated soils will be moved to Change Order # 02.
- 2.13 Additional efforts to remove wooden fence, import soil, delay caused by soils technician's equipment failure, placement of 10" PCC at grade bust, and additional pavement sawcutting and removals at each end of bike trail to create suitable joins with existing pavements.
- 2.14 The plans indicated irrigation equipment was to be located in the parkway behind the curb and gutter, at intersections of 6<sup>th</sup> St. at Orizaba, Loma, and Grand Ave., with irrigation lines extending from the City water main to the irrigation equipment and to the intersection traffic circle. The agreed changed location for the irrigation equipment was into the intersection traffic circle; which shortened irrigation lines and placed the water meter in the traffic circle. The contractor worked in collaboration with the Water Department to minimize work efforts and public inconvenience.
- 2.15 The plans indicated landscaping, including three 36" box King Palms, were to be located within a 12-foot diameter traffic circle. The City directed a 24-foot diameter traffic circle for this intersection and directed three 48" box King Palms be provided and installed in order to meet project objectives for the larger landscaped area.
- 2.16 The plans indicated landscaping, including three 5-gallon Agave plants, were to be located within a 12-foot diameter traffic circle. The City directed a 24-foot diameter traffic circle for this intersection and directed eighteen 15-gallon Agave plants be provided and installed in order to meet project objectives for the larger landscaped area.
- 2.17 The plans indicated landscaping, including root barriers, were to be located within a 12-foot diameter traffic circle. The City directed a 24-foot diameter traffic circle for this intersection and directed additional root barriers be provided and installed in order to meet project objectives for the larger landscaped area.
- 2.18 The plans indicated landscaping, including six 36" box King Palms, were to be located within two 12-foot diameter traffic circle. The City directed a 24-foot diameter traffic circle for these intersections and directed six 48" box King Palms be provided and installed in order to meet project objectives for the larger landscaped area.
- 2.19 The plans indicated landscaping, 30-day landscape maintenance, was to be located within twelve 12-foot diameter traffic circle. The City directed a 24-foot diameter traffic circle for these intersections and directed 30-day landscape maintenance be provided for the increased landscaped areas in order to meet project objectives for the larger landscaped area.

## B. EXTRA WORK/ADJUSTMENT IN COMPENSATION AT AGREED PRICE

In accordance with procedures for changes in the work established in the specifications, you are authorized to do the following:

3.1 This payment includes costs for work at the intersection of 6<sup>th</sup> Street and Park Ave to remediate unstable roadway subgrade. These costs include removal of AC, pavement fabric, PCC, and unsuitable materials; placement of geogrid fabric and CMB. Provide all labor, materials, equipment, and installations of the additional items, as directed by the Project Manager, for the lump sum of \$59,853.25.

- 3.2 This payment includes costs for work at the intersection of 6<sup>th</sup> Street and Park Ave to place and grade Crushed Miscellaneous Base course. Provide all labor, materials, equipment, and installations of the additional items, as directed by the Project Manager, for the lump sum of \$3,402.20.
- 3.3 This payment includes costs for all work associated with relocating irrigation equipment and connecting the irrigation to City water main at the intersection of 6<sup>th</sup> St. and Havana Ave. These costs include asphalt pavement removal, soil excavation, metal trench plates, trench backfill and compaction, and full depth asphalt concrete trench paving. Provide all labor, materials, equipment, and installations of the additional items, as directed by the Project Manager, for the lump sum of \$5,800.78.
- 3.4 The Change Order for irrigation connection to City water main at the intersections of 6th St. at Ultimo and Santiago Ave will be moved to Change Order # 02.
- 3.5 This payment includes costs for all work associated with relocating irrigation equipment and connecting the irrigation to City water main at the intersections of 6<sup>th</sup> St. at Obispo, Temple and Molino Ave. These costs include asphalt pavement removal, soil excavation, metal trench plates, trench backfill and compaction, and full depth asphalt concrete trench paving. Provide all labor, materials, equipment, and installations of the additional items, as directed by the Project Manager, for the lump sum of \$4,360.60.
- 3.6 This payment includes costs to place and maintain arrow board and changeable message board signs for the 6<sup>th</sup> St. Bike Blvd. project from 7/28/2017 to 11/3/2017. Provide all labor, materials, equipment, and installations of the additional items, as directed by the Project Manager, for the lump sum of \$21,672.50.
- 3.7 This payment includes costs place and maintain water filled k-rail traffic control devices for the 6th St. Park Ave. project area from 8/29/2017 to 10/4/2017. Provide all labor, materials, equipment, and installations of the additional items, as directed by the Project Manager, for the lump sum of \$1,311.08.
- 3.8 This payment includes costs to place and maintain BMPs for temporarily stockpiled contaminated soils placed at the Long Beach Airport yard. Provide all labor, materials, equipment, and installations of the additional items, as directed by the Project Manager, for the lump sum of \$1,435.28.
- 3.9 This payment includes costs to modify the size and location of the intersection traffic circle at 6<sup>th</sup> St. and Roswell Ave to match field conditions. Provide all labor, materials, equipment, and installations of the additional items, as directed by the Project Manager, for the lump sum of \$3,831.15.
- 3.10 This payment includes costs to patch back construction slot with PCC to match existing pavement section at the intersections of 6<sup>th</sup> St. at Termino, Molino, Grand, and Obispo Ave. Provide all labor, materials, equipment, and installations of the additional items, as directed by the Project Manager, for the lump sum of \$2,153.85.
- 3.11 This payment includes costs for all work associated with relocating irrigation equipment and connecting the irrigation to City water main at the intersection of 6<sup>th</sup> St. and Termino Ave. These costs include asphalt pavement removal, soil excavation, metal trench plates, trench backfill and compaction, and full depth asphalt concrete trench paving. Provide all labor, materials, equipment, and installations of the additional items, as directed by the Project Manager, for the lump sum of \$1,980.28.
- 3.12 The Change Order for removing temporarily stockpiled contaminated soils will be moved to Change Order # 02.
- 3.13 This payment includes costs to remove wooden fence, import soil, delay caused by soils, technician's equipment failure, placement of 10" PCC at grade bust, and additional pavement sawcutting and removals at each end of the 6th St. bike trail. Provide all labor, materials, equipment, and installations of the additional items, as directed by the Project Manager, for the lump sum of \$7,990.56.
- 3.14 This payment includes costs for all work associated with relocating irrigation equipment and connecting the irrigation to City water main at the intersections of 6<sup>th</sup> St. at Orizaba, Loma, and Grand Ave. Provide all labor, materials, equipment, and installations of the additional items, as directed by the Project Manager, for the lump sum of \$4,558.96.
- 3.15 This payment includes costs to increase the box size from 36" to 48" of the three King Palms provided and installed at the intersection of 6<sup>th</sup> St. at Roswell Ave. Provide all labor, materials, equipment, and installations of the additional items, as directed by the Project Manager, for the lump sum of \$7,950.00.

- 3.16 This payment includes costs to plant an additional fifteen 5-gallon Agave plants at the intersection of 6<sup>th</sup> St. at Roswell Ave. Provide all labor, materials, equipment, and installations of the additional items, as directed by the Project Manager, for the lump sum of \$3,243.60.
- 3.17 This payment includes costs to install additional root barrier at the intersections of 6<sup>th</sup> St. at Roswell, Temple, Molino, Obispo, Orizaba, Loma, Termino, Grand, Havana, Santiago, Flint, Ultimo Ave. Provide all labor, materials, equipment, and installations of the additional items, as directed by the Project Manager, for the lump sum of \$2,577.92.
- 3.18 This payment includes costs to increase the box size from 36" to 48" of the six King Palms provided and installed at the intersections of 6th St. at Termino and Grand Ave. Provide all labor, materials, equipment, and installations of the additional items, as directed by the Project Manager, for the lump sum of \$15,900.00.
- 3.19 This payment includes costs for 30-day landscape maintenance for the additional landscape areas created by larger traffic circles constructed at the intersections of 6<sup>th</sup> St. at Roswell, Temple, Molino, Obispo, Orizaba, Loma, Termino, Grand, Havana, Santiago, Flint, Ultimo Ave. Provide all labor, materials, equipment, and installations of the additional items, as directed by the Project Manager, for the lump sum of \$11,975.01.

The Agreed Lump Sum Costs described above total \$159,997.02 and include all contractor markups.

By signing this change order, the Contractor acknowledges that it is familiar with California Civil Code Section 1542, which reads: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor;" and Contractor hereby releases the City of Long beach from any unknown claims and waives its rights under Section 1542.

The Prices set forth herein above shall be considered full compensation for all obligations of the Contractor associated with this change order, and the City will not be liable for any claim of the Contractor for delays or extra compensation resulting from performance of the requirements of this change order.
