

1 FIRST AMENDMENT TO CONTRACT NO. 34755

3 THIS FIRST AMENDMENT TO CONTRACT NO. 34755 is entered into,
4 duplicate, effective as of March 6, 2019, for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting held on July 18,
6 2017, by and between CENTRO C.H.A. INC., a California corporation ("Contractor"), with
7 offices located at 1633 Long Beach Blvd., Long Beach, California 90813, and the CITY OF
8 LONG BEACH, a municipal corporation ("City") and administering entity for Pacific
9 Gateway Workforce Investment Network.

10 WHEREAS, City and Contractor (the "Parties") entered into Contract No.
11 34755 whereby Contractor agreed to provide recruitment, outreach, and staffing services
12 to English Language Learners (ELL) project; and

13 WHEREAS, the Parties desire to add \$34,000 to Contract No. 34755 and
14 extend the term an additional three (3) month period;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the Parties agree as follows:

17 1. Section 2.A of Contract No. 34755 is hereby amended to read as
18 follows:

19 "A. The term of this Contract ("Term") shall be deemed to have
20 commenced as of Jun 1, 2017, and unless sooner terminated pursuant to the provisions
21 hereof, shall terminate on March 31, 2019. Either of the parties hereto shall have the right
22 to terminate this Contract in its entirety at any time during the Term for any or no reason
23 whatsoever by giving fifteen (15) days prior written notice of termination to the other party.
24 City shall have the additional right to cancel any part of this Contract at any time during the
25 Term for any reason whatsoever by giving fifteen (15) days' notice of such cancellation to
26 the Contractor."

27 2. Section 5.A. of Contract No. 34755 is hereby amended to read as
28 follows:

1 "A. The total amount which shall be payable by City to Contractor for
2 Contractor's allowable services during the Term shall not exceed One Hundred Thirty-Six
3 Thousand Dollars (\$136,000)."

4 3. Except as expressly amended herein, all terms and conditions in
5 Contract No. 34755 are ratified and confirmed and shall remain in full force and effect.
