1 FIRST AMENDMENT TO CONTRACT NO. 33610

3 THIS FIRST AMENDMENT TO CONTRACT NO. 33610 is made and  
4 entered, in duplicate, as of August 19, 2015, for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on  
6 August 18, 2015, by and between HAAKER EQUIPMENT COMPANY, a California  
7 corporation ("Contractor"), whose address is 2070 N. White Avenue, La Verne, California  
8 91750, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the parties entered into Contract No. 33610 whereby  
10 Contractor agreed to provide Elgin Pelican street sweeper parts; and

11 WHEREAS, the parties desire to increase the annual contract amount by  
12 \$100,000;

13 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
14 conditions herein contained, the parties agree as follows:

15 1. Section 2 of Contract No. 33610 is hereby amended to read as  
16 follows:

17 "2. City shall pay Contractor in due course of payments, following  
18 receipt of an invoice from Contractor and upon acceptance from the City for the street  
19 sweeper parts the prices shown in Exhibit "A", an annual amount not to exceed Three  
20 Hundred Fifty Thousand Dollars (\$350,000.00), including tax for the first year of the  
21 Contract, ending October 31, 2015. City shall pay Contractor in due course of payments  
22 an annual amount not to exceed Two Hundred Fifty Thousand Dollars (\$250,000.00),  
23 including tax for the duration of the Contract, including any extensions or renewals."

24 2. Except as expressly modified herein, all of the terms and conditions  
25 contained in Contract No. 33610 are ratified and confirmed and shall remain in full force  
26 and effect.
