This Memorandum of Understanding (MOU) regarding Kaiser Permanente Child Heal (KPGHP) funding distributed on June 15, 2006, is entered into by and among Kaiser Foundation Health Plan, Inc., a California nonprofit, public benefit corporation (KFHP). Kaiser Foundation Hospitals (KFH), a California nonprofit, public benefit corporation and ("Donee"). "Health Plan and Hospitals" shall be collectively referred to herein as "Kaiser Permanente".

This Memorandum of Understanding sets forth the terms and conditions under which Kaiser Permanente shall donate funds in the amount of \$25,000 to Donee. Such terms and conditions are as follows:

1. By June 15, 2006, Kaiser Permanente will make the \$25,000 Donation to the City of Long Beach for use by its Department of Health and Human Services.

Donee will provide a list of objectives and budget in a request form (attached) showing how funds will be allocated to achieve objectives.

Donee shall not use all or any portion of the Donation to (a) support political campaigns, (b) support or influence any government legislation except making available the results of non-partisan analysis, study or research, or (c) grant an award to another party.

- 2. Donee shall maintain accounting records sufficient to identify the Donation and to whom and for what purpose such funds are expended. Further, Donee shall make such records available for inspection by representatives of Kaiser Permanente and to maintain such records for at least four (4) years after the Donation has been expended.
- 3. Donee agrees to meet with other Kaiser Permanente Child Health Plan grant recipients to discuss progress of different outreach models and share learnings with each other. Donee also agrees to comply with enrollment schedule and follow instructions from Kaiser Permanente staff regarding interruptions in enrollment to the Child Health Plan whenever necessary.
- 6. If Kaiser Permanente determines that Donee has failed to abide by the terms and conditions of the Donation as stated in this Memorandum and enclosed request form, Kaiser Permanente may require that any portion of the Donation then unexpended be immediately returned.
- 7. Donee will refer to KPCHP as the Kaiser Permanente Child Health Plan, and may not use the Kaiser Permanente logo unless with prior approval.
