

1 FIRST AMENDMENT TO AGREEMENT NO. 35268

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 35268 is made and
4 entered, in duplicate, as of March 30, 2021 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on June
6 18, 2019, by and between FLEET COLLISION SERVICES, INC., a California corporation
7 ("Contractor"), with a place of business at 14833 Lakewood Blvd., Paramount, CA 90723,
8 and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with light and medium vehicle body repair ("Project"); and

11 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
12 35268 (the "Agreement") whereby Consultant agreed to provide these services as
13 described in Request for Proposals number FS19-042; and

14 WHEREAS, the Parties desire to increase funds and renew the contract for
15 an additional one-year period and;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions herein contained, the Parties agree as follows:

18 1. Section 1.A. of the Agreement is hereby amended to read as follows:

19 "A. Contractor shall furnish specialized services more particularly
20 described in Exhibit "A", attached to this Agreement and incorporated by this reference, in
21 accordance with the standards of the profession, and City shall pay for these services in
22 the manner described below, not to exceed Six Hundred Thousand Dollars (\$600,000)
23 annually, at the rates or charges shown in Exhibit "B"."

24 2. Section 2 of the Agreement is hereby amended to read as follows:

25 "The term of this Agreement shall commence at midnight on July 1, 2019,
26 and shall terminate at 11:59 p.m. on June 30, 2022, with the option to renew for two (2)
27 additional one (1) year periods, unless sooner terminated as provided in this Agreement.
