NOW, THEREFORE, in consideration of the mutual terms and conditions in the Agreement and in this Second Amendment, the parties agree as follows:

- 1. Section 2 of Agreement No. 31810 is hereby amended to read as follows:
 - "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on August 23, 2010, and shall terminate at 11:59 p.m. on August 22, 2013, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
- Except as expressly amended in this Second Amendment, all terms and conditions in Agreement No. 31810 are ratified and confirmed and shall remain in full force and effect.
