1 FIRST AMENDMENT TO REVOCABLE USE PERMIT NO. 34938

3 THIS FIRST AMENDMENT TO REVOCABLE USE PERMIT NO. 34938 is  
4 made and entered, in duplicate, as of February 3, 2020, for reference purposes only,  
5 pursuant to authorization by the PARKS AND RECREATION COMMISSION of the City of  
6 Long Beach ("Commission") at its meeting on November 20, 2014, by and between the  
7 CITY OF LONG BEACH, a municipal corporation ("City") and EL DORADO ARCHERS,  
8 INC., a California nonprofit corporation ("Permittee"), whose address is 12631 Imperial  
9 Highway, Suite E-129, Sana Fe Springs, California 90670.

10 WHEREAS, the City granted Permittee the non-exclusive use of the eastern  
11 portion of the Olympic Range and the Indoor/Flint Range at the El Dorado Archery  
12 Range; and

13 WHEREAS, Permittee may use the Permit Area for the conduct of  
14 instruction, safety classes, and member practice in archery; and

15 WHEREAS, the parties desire to extend the term of Permit No. 34938 and  
16 update the Use to include a three (3) foot safety perimeter around the Storage Room  
17 electrical panel;

18 NOW, THEREFORE, in consideration of the mutual terms and conditions in  
19 Permit No. 34938, the parties agree as follows:

20 1. Section 3.A of Permit No. 34938 is hereby amended to read as  
21 follows:

22 "A. The term of this Permit shall commence at midnight on  
23 October 1, 2014, and shall terminate at 11:59 p.m. on September 30, 2021, unless  
24 sooner terminated as provided in this Permit. The term may be extended for one  
25 (1) two-year period at the discretion of the Director."

26 2. Section 1.E is hereby added to Permit No. 34938 to read as follows:

27 "E. Permittee shall maintain a three (3) foot safety perimeter  
28 around the Storage Room electrical panel, which restricts access to all
