1 FIRST AMENDMENT TO CONTRACT NO. 34416

3 THIS FIRST AMENDMENT TO CONTRACT NO. 34416 is made and
4 entered, in duplicate, as of August 28, 2018 for reference purposes only, pursuant to
5 Resolution No. RES-16-0073, adopted by the City Council of the City of Long Beach at its
6 meeting on August 9, 2016, by and between KOPPL PIPELINE SERVICES, INC., a
7 California corporation ("Contractor"), with a place of business at 1228 Date Street,
8 Montebello, California 90640 , and the CITY OF LONG BEACH ("City"), a municipal
9 corporation.

10 WHEREAS, City and Contractor (the "Parties") entered into Contract No.
11 34416 pursuant to Resolution No. RES-16-0073 whereby Contractor agreed to provide
12 pipeline stopper fittings and tapping and stopping services for natural gas pipelines
13 greater than 12-inches in diameter; and

14 WHEREAS, the Parties desire to extend the term one (1) additional one-
15 year term;

16 NOW, THEREFORE, in consideration of the mutual terms and conditions
17 contained herein, the Parties agree as follows:

18 1. Section 3 of Contract No. 34416 is hereby amended to read as
19 follows:

20 "3. The term of this Contract shall commence on October 1, 2016, and
21 shall terminate at midnight on October 1, 2019 unless sooner terminated as provided
22 herein. The Contract may be extended for one (1) additional one-year period, at the
23 discretion of the City Manager. The City may terminate this Contract by giving thirty (30)
24 days prior notice of termination to Contractor."

25 2. Except as expressly modified herein, all of the terms and conditions
26 contained in Contract No. 34416 are ratified and confirmed and shall remain in full force
27 and effect.
