### Memorandum 3rd Council District

### Subject: 5000 East 2<sup>nd</sup> Street, dba Urban Table, ABC License

I am submitting the following conditions for your consideration for an original application for an On-Sale Beer and Wine license for a bonafide eating place.

- 1. Sales, service, and consumption of alcoholic beverages shall be permitted only between the hours of 8:00 am until 10:00 pm Sunday through Saturday.
- 2. The quarterly gross sales of alcoholic beverages shall not exceed 30% of the gross sales of food during the same period. The licensee shall at all times maintain records which reflect separately the gross sale of food and gross sales of alcoholic beverages of the licensed business. Said records shall be kept no less frequently than on a quarterly basis and shall be made available on demand.
- 3. There shall be no exterior advertising or sign of any kind or type, including advertising directed to the exterior from within, promoting or indicating the availability of alcoholic beverages.
- 4. No "happy hour" type of reduced price alcohol beverage promotion shall be allowed.
- 5. The licensee shall provide night lighting and other security measures to the satisfaction of the LBPD.
- 6. The licensee shall prevent loitering or other activity in and near the premises that could be nuisance to adjacent uses and/or residential neighborhoods.
- 7. The seating shall consist of tables and/or booths. There shall be no sitting or standing bar area.
- 8. There shall be no pool or billiards tables, amusement machines, video game devices, coin operated game machines or televisions on the premises at any time.
- 9. No live entertainment or dancing, no disc jockey and no amplified music shall be permitted on the premises at any time.
- 10. The use of any amplified system or devise is prohibited outdoors, and the use of any such system or devise inside the premises shall not be audible outside the premises.

- 11. The licensee shall be responsible for maintaining free of litter and graffiti the area adjacent to the premises over which they have control. All graffiti on the premises shall be removed or covered with in 24 hours of its appearance.
- 12. The rear doors of the premises shall be maintained closed with solid doors at all times, except for deliveries of merchandise and removal of trash, garbage, and other waste or recyclable material.
- 13. The licensee shall ensure that shipping and/or receiving activities occur only between 8 am and 10pm.
- 14. The licensee shall ensure that trash and other refuse is deposited in closed containers, outside and in the rear of the premises, and only between 8 am and 10 pm.
- 15. The licensee shall ensure that outside trash and refuse containers are serviced by sanitation companies only between 8 am and 10 pm.
- 16. The licensee shall ensure that alleys, streets, or other public areas are not used by employees and/or contractors of the licensee for equipment or utensil cleaning or other sanitary purposes.
