3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH AUTHORIZING THE CITY  
5 MANAGER, OR HIS DESIGNEE, TO SUBMIT A GRANT  
6 APPLICATION FOR UP TO \$250,000 UNDER THE  
7 CALIFORNIA DEPARTMENT OF TRANSPORTATION  
8 (CALTRANS) FISCAL YEAR 2012-2013 ENVIRONMENTAL  
9 JUSTICE TRANSPORTATION PLANNING GRANT

11 WHEREAS, the California Department of Transportation (Caltrans) invites  
12 applications for Fiscal Year 2012-2013 Environmental Justice Transportation Planning  
13 with funds available for the preparation of transportation planning studies; and

14 WHEREAS, Environmental Justice Transportation Planning Grants are  
15 intended to promote strong and healthy communities, economic growth, and enhanced  
16 mobility within cities; and

17 WHEREAS, the City of Long Beach desires to develop new implementation  
18 strategies for Artesia Boulevard in order to create a healthy and revitalized multi-modal  
19 commercial corridor serving the needs of the surrounding neighborhoods (the "Project");

20 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
21 follows:

22 Section 1. That the City Manager, or designee, is authorized to apply to  
23 the California Department of Transportation (Caltrans) for an Environmental Justice  
24 Transportation Planning Grant to provide funds for the Project.

25 Section 2. That the City Manager, or designee, is authorized to take all  
26 necessary steps to secure the grant funds from Caltrans to provide funds for the Project.

27 Section 3. That the City Manager, or designee, is authorized and  
28 empowered to conduct all negotiations, execute and submit all documents, including but

1 not limited to contracts, subcontracts, applications, agreements, extensions, renewals,  
2 payment requests, and amendments of funding providing by Caltrans which may be  
3 necessary for the completion of the Project.

4 Section 4. That the City Manager, or designee, is authorized, for and on  
5 behalf of the City, to accept, appropriate, expend, and administer the grant funds, if  
6 secured, in accordance with the terms and conditions set forth in the approved grant for  
7 the Project.

8 Section 5. This resolution shall take effect immediately upon its adoption  
9 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
